Proof of certification or registration to become certified must be provided with the bid. The Crown will accept a letter from a registered external ISO Auditor as proof of a Bidders ISO registration process or a contract for ISO Advisory Services with accompanying detailed Statement of Work that includes the Facilitation of a Registrar Certification audit with an ISO Registrar will be accepted if the contract start date was within the past twelve (12) months."

Regarding M1, section 3 states:

"If the Bidder is using TBIPS contracts to demonstrate experience, listing the TBIPS resource categories will suffice if the resource categories used to demonstrate are the same as the resource categories required in the solicitation as listed in the table above.
