THE PURPOSE OF THIS AMENDMENT IS TO GIVE EFFECT TO THE FOLLOWING CHANGE;

## 1) Questions and Answers #1;

Q1: Do we have access to the interior of the building?

A1: Interior access will be required in order to complete the metal work outlined in the documents, contractor to arrange access with Parks Canada when required.

Q2: How far down does the restoration work on the walls and buttresses go?

A2: Work is limited to above grade, there will be no work requiring excavation.

Q3: Where can we have a layup area for material storage and equipment?

A3: Layup areas will be determined after award of contract.

Q4: Are the doors and shutters to be replaced or repaired.

A4: Work on doors and windows are outline in the drawings and specifications, they are required to be cleaned and repaired where needed.

Q5: Are we to leave the copper roofing material on site?

A5: Yes, the old copper material is to stay onsite and remain property of Parks Canada.

Q6: Will we be required to allow public access to the building during construction?

A6: No, the building will be closed to the public for safety during construction, although surrounding areas will be required to allow public to walk around and access the tunnel.

Q7: Are we able to use a bagged mortar mix in lieu of site mixed? Using site mix will delay work for approximately 28 days to allow for testing.

A7: Bagged mortar mix will be considered after contract award.

Q8: Who attended the site visit?

A8: See attached.
