This document is raised in order to answer the following questions, amend the time zone for the Request for Proposal (RFP), and update the Basis of Payment.

Question #3

Could you please offer the thickness of the Laminated disc tags?

Answer #3

The thickness of the tags currently in use is 0.040". However, as noted in section 4.1.1.1 Mandatory Technical Criteria, Bidder must provide proof that their disc tags and pins have been successfully used for the purpose of salmonid research studies, specifically salmon assessment and enumeration on the spawning grounds, for a minimum of 5 years. Therefore proposed tags that are thicker or thinner may be acceptable, so long as they meet 4.1.1.1.

Question #4

If applicable, please offer some detailed pictures of the side face of the tags?

Answer #4

Since the tags are only 0.04", it is very difficult to photograph.

Question #5

What's the material of the tags? Is it acrylic or other else?

Answer #5

The material of the tags currently in use is proprietary information belonging to the manufacturer.
