REVISION 001

This revision 001 is raised to publish a question and an answer, to modify the Request for Standing Offer and to re-publish the Annex D - Pricing, as follows:

1.0 QUESTION / ANSWER:

Q1. : In reviewing clause 7.5.1.8 – Basis of Payment Shipping, we noted that Canada is requesting pricing without any allowance for profit or administrative overhead. Without prejudice, please allow us to clarify that in our industry it is a common practice that signage requires handling of oversized and uncommon packaging which includes labor & material as well as administrative resources to expedite a signage project to destination. This labor and material is not covered in other sections of this Request for Standing Offer and could amount to a significant sum in the quantities of projects that need to be processed. Consequently, would there be a possibility that your authority would reconsider adding an allowance or a percentage on actual incurred costs with proof of billing as needed.

A1. Canada will allow offeror to offer hourly rate for preparation and handling fees in section 14B of the pricing table in Annex D – Pricing. See Request for Standing Offer modification below.

2.0 MODIFICATION / REQUEST FOR STANDING OFFER

At Part 7 – B - Resulting Contract Clause article 7.5 Payment - 7.5.1.3 Basis of Payment for Custom Production, Graphic Design Services and Refurbishing.

DELETE: In its entirety.

INSERT: 7.5.1.3 - Basis of Payment for Custom Production, Graphic Design Services, Refurbishing, Preparation and Handling fees.

Firm all-inclusive hourly rates in accordance with Annex D- Pricing, Table 14B, Canadian Custom Duties and Excise Taxes included where applicable and Applicable Taxes Extra.
