SOLICITATION AMENDMENT # 001

This solicitation amendment is raised to:

1. Address the following questions submitted during the solicitation period as per RFP; and
2. Amend the RFP.

Part 1 – Questions and Answers

Q1. We clearly meet the technical requirements for teaching one of the two official languages: French.

It is unclear to us whether you will consider a proposal that meets only the need for one language.

A1. The CRA will accept bids for one of the official languages in regions 2, 3, 4 and 5 only. If Bidders submit a proposal for one or both languages in one region, then Bidders must submit a proposal for each language and each region separately, and must meet all of the Mandatory Criteria for each stream.

The requirements to bid on both Official Languages for Region 1 will not change.

The CRA has modified the RFP to address this change. Please see amendment below.

Q2. The definition of full-time language training in item 4.0 (37.5 hours a week, 35 with a teacher and 2.5 self-study) raises some questions:

Is 7.5 hours billed every day?

If not, are you requesting that self-study be done in the classroom? If so, language schools should bill time spent in the classroom. If self-study is done outside the classroom, there is a loss of over 7% in the number of hours normally spent on language training.

A2. No, Contractors must bill up to a maximum of 7 hours per day for full-time language training.

Contractors must only bill for actual training provided, which is the equivalent of 7 hours per day. Learners are provided with 0.5 hours per day for self-study during which time there is no language instruction being delivered, however,. Contractor's training rooms must remain available to learners should they prefer to conduct self-study at the Contractor's premises.

Q3. The new language training program with new language objectives for Public Works group courses is based on a schedule of six 12-week stages with 37.5 billable hours in the classroom for a total of 2,700 in group courses for the complete full-time program. Will the Canada Revenue Agency ask its suppliers to rely on the new PSPC program or require another program?

A3. No, as per section 5.3, Training Programs and Objectives of Annex A, the Contractor must use the stated training programs to provide language training to Agency employees. And it must ensure that teachers are trained on this program and training programs. On the other hand, the supplier may use the training materials of its choice.

Q4. Please specify the total points for region 1, when we do the total for PR1 to PR10, are 344 instead of the 348 mentioned on page 29.

A4. The correct point total is 340. Please see change C6 below.

Q5. Criterion PR2, Bidder's Experience, if the calculation is done to have the maximum of points, we must show 12 years (2 points x 12 years = 24 points). Since 2010, the calculation has yielded only 10 full years.



A5. 20 points (2 points X 10 years = 20 points) are available under PR2 a) Number of years experience is 20. Please see change C7 below.

Q6. Criterion PR3, Advisors' Experience: Please specify that you give the same maximum number of points (28) for an advisor with a maximum of experience in supervision as you do for an advisor with a maximum of experience in teaching.

A6. Yes, the total number of points is the same for the experience for an advisor who has supervisory experience as an advisor with teaching experience.

Q7. You ask for one price per placement test, not for the diagnostic tests. Is the price for the diagnostic tests at the supplier's discretion?

A7. This was an oversight. Please see change C8 below.

Q8. We ask that the closing date be postponed so that we can prepare our bid.

A8. The CRA agrees to the request. The solicitation period has been extended to April 9, 2020. Please see change C1 below.

Regions 2, 3, 4 and 5: Bidders may submit a proposal for the provision of English language training services, for the provision of either French language training services or both.

Bidders can bid on more than one region. In the event that a single Bidder is deemed the highest ranked responsive bid for multiple regions and languages, the CRA may, at its sole discretion, award one (1) contract for the services.

The Bidder propose its firm all-inclusive hourly rates per learner and unit rates per placement test for the initial period and each option period of the contract.

For Region 1, bidders must propose a firm all-inclusive hourly rate per learner (English and French language training) for the for the National Capital Region and a single firm all-inclusive hourly rate per learner (English and French language training) for Ontario.

For Regions 2, 3, 4 and 5, bidders must propose a single firm all-inclusive hourly rates per learner for the language it is proposing (i.e. English language training or French language training)

The volumetric data included in the pricing tables below are provided solely to calculate the evaluation price of each bid. They are not to be considered a contract guarantee.

Each region will be evaluated separately.

For Regions 2, 3, 4 and 5, The bid evaluation price will be calculated by region and language by summing the Total Evaluation Price of years one to seven (i.e. there will be a unique bid evaluation price for English language training as well as French language training in each Region).

The prices specified include all of the requirements defined in Annex A, "Statement of Work".
