Solicitation Amendment No. 003

This solicitation is hereby amended to provide the following questions and answers:

Q1. Please identify the Make, Model, and Part Number of the in-service day optic.

A1. The Optical Scope is the Schmidt & Bender 5-25x56 PMII.

Modifications required:

- *Annex C1, Para 1.3 Definitions,*
ADD: "Optical Scope" The optical scope is a Schmidt & Bender 5-25x56 PMII, with a distance between the center of the eyepiece and the top of the NATO rail of 38.1mm \pm 1mm.
- *Annex C2, Para 1.3 Definitions,*
ADD: "Optical Scope" The optical scope is a Schmidt & Bender 5-25x56 PMII, with a distance between the center of the eyepiece and the top of the NATO rail of 38.1mm \pm 1mm.

Q2. Height above rail of the in-service day optic.

A2. The distance between the center of the eyepiece of the Optical Scope and the top of the NATO rail is 38.1mm +/- 1mm.

Q3. Distance/gap between in-service day optic and the Image Intensifier and/or Thermal Imaging device.

A3. The distance between the Optical Scope and the IIITIS should be recommended by the bidder/manufacturer of the IIITIS.

- *No modifications required.*

Q4. Is there a cover/boot currently in service? If so, what is the Make & Model. Alternatively, can Canada identify a commercially available Make & Model that would be compliant?

A4. The Canadian Army Snipers do not currently have an in-service interface cover. Canada cannot identify a commercially available interface cover as the design of the cover relies on the design of the IIITIS being proposed by the bidder.
