This amendment is raised to provide additional information related to the Common Heavy Equipment Replacement (CHER) project.

SACC Standard Instructions allows for Joint Ventures if the Bidder chooses to use this type of legal entity for their bid.

According to the 2003 Standard Instructions, the definition of "Bidder" does not include "the parent, subsidiaries or other affiliates of the Bidder, or its subcontractors." Therefore, unless the bidder is in a joint venture, the essential criteria of a subcontractor cannot be taken into consideration.
