# **QUESTIONS AND ANSWERS**

Question 10: Please specify the make, model and year of the vehicles for the cameras to be mounted on?

**Answer 10:** Makes, models and years can vary, i.e. Cargo Vans, Minivans, Cars, Trucks and SUV's, as it is dependent upon operational use.

Question 11: Please specify the make and details of the vehicle light bars?

**Answer 11:** We have multiple vehicle light bars in use, and which light bar depends on the existing equipment of the vehicle it is being installed upon, see Answer 10).

**Question 12:** Does the vehicles have a power management system?

**Answer 12:** Some vehicles have a power management system, others do not, as it depends on the existing equipment of the vehicle it is being installed upon, see Answer 10).

Question 13: Please specify MDT make and model?


**Answer 13:** The MDT is dependant upon the existing equipment of the vehicle it is being installed upon, see Answer 10).

**Question 14:** In Sec 4.14, could you please clarify which 'other' agencies RCMP "D" Division would like to share data with? Are these internal to Manitoba, Canada, and/or US. Also, are these municipal, provincial or federal agencies?

**Answer 14:** Due to operational reasons, we are not able to provide or release this information, which is not relevant to the procurement of the ALPR units.

**Question 15:** Solicitation Amendment 2: Question 3: We can provide an Other mobile LPR system that can integrate with (i.e. feed LPR data to) the Genetec AutoVu LPR security Center, our mobile system will run Other software that is used by other police agencies worldwide, it cannot run Genetec AutoVu Patroller.

Please clarify if this is a feasible option and we will proceed with participating in this opportunity. Images 1-3 provides an example that clearly shows what we can offer. Would this be acceptable?

**Question 16:** Mandatory Technical Requirements, Item 1.6 - The height of the camera must not be greater than 3.0 inches or a diameter of 4.5 inches, and must be compact enough to be permanently attached to the vehicle's emergency light bar in a low profile manner to minimize impact on the light bar system without drilling multiple holes or violating the integrity of the roof structure (other than for cable passage through the roof).

Image 4 is an example of our mobile camera that we can offer.

Can this section of the tender be revised to allow for our dimensions?



**Answer 16:** The ALPR maximum dimensions were specifically chosen to allow for the installation of the cameras on "any" vehicle in the fleet. This includes mounting the cameras in pairs, side by side and perpendicular together, along with other emergency equipment. When the cameras are mounted and if they come into contact with any other surface, such as another camera, the roof line or the light bar, the vibrations will render them useless and can destroy the housing.

**Question 17:** Mandatory Technical Requirements, Item 5.4 - After issuance of the Contract, all hardware and software must be delivered to the customer site:

- a) on or before May 29, 2020 for the initial contract order, and
- b) up to six weeks for option orders, upon receipt of order.

Given the current environmental situation (COVID-19), hardware delivery is expected to be between 8 weeks from contract signature. Can the tender be modified to allow for this delivery timeframe?

Answer 17: The options delivery date has been changed to eight (8) weeks, see above Item 5.4.

Question 18: Can we know how many RCMP technicians are expected to be certified?

**Answer 18:** We would require Manufacturer certification for Three (3) Administration people in the use of the vehicle ALPR software, for upload into the existing Genetec back office software, and for Fifteen (15) Technicians for installation of ALPR hardware/software into the vehicles.
