# THIS AMENDMENT IS RAISED TO RESPOND TO BIDDER QUESTIONS.

Q91 We believe it is essential that Canada reconsider its position regarding the closing date for this invitation to tender and postpone it to June 30, 2020 (at a minimum).

In light of the current COVID-19 situation, we are asking for a 2 month extension for the RFP submission. We are working with multiple entities globally who have all placed heavy restrictions and work flow which is hindering our ability to provide the best proposal to the Canadian Government. I appreciate your efforts thus far as I know it has been difficult for government workers as well with the limited VPN access.

- A91: Canada will extend the closing date to 29 May 2020. Additional extensions will be considered as the COVID-19 situation continues to evolve in Canada and internationally.
- Q92 Having reviewed the test procedure we note that it has not changed since the original 2007 RFP. We are very concerned that testing protocols fall well short in their ability to demonstrate that the equipment being evaluated will meet the real world needs of the CAF.
- A92 Thank you for taking the time to review the documents and making some astute observations. If you have specific questions for us to address please let us know.

The test procedure is very similar to the one used in ADIS IPT 2008, with small changes throughout. We understand that this lab test does not demonstrate the entirety of ADIS' requirements. The testing is focused on comparing the sensitivity of the sensor systems under evaluation. The lab test is not intended to simulate field tests.

- Q93 On Page 42 of 77 You state "Bidders that offer non-FTIR Systems will be consulted on the test plan as indicated below". Is there a reason why this preferential offer is provided to Non-FTIR suppliers? We would like to have the opportunity to discuss with the TA possible amendments to the test procedure in order that changes be made that shall enable **all** contractors to demonstrate the capabilities of the sensors with greater scientific accuracy that also relates to operational capability.
