Amendment 002 to Solicitation W3048-19KE74/A – Soft Body Armour Systems

The purpose of this amendment is to:

1. Post questions received from bidders and the answers; and
2. Amend the solicitation.

1.

Question 1: A section of Part 4.1.1.1, Mandatory Technical Criteria 2, reads “Listed Company: Must be the Offeror” and a part of Section 5.2.3.1 reads “the manufacturer that produced the pre-award sample will remain unchanged for the duration of the Standing Offer”. In our case, we would be acting as a reseller of the manufacturer. Would our offer be response?

Answer 1: Your offer would not demonstrate compliance to Mandatory Technical Criteria 2 in accordance with requirements of 2B. However, you could still demonstrate compliance in accordance with 2A.

Question 2: In order to ensure we well understand what is exactly the hard armour plate you want to use in the Soft Body Armour System, could you please inform us about its curvatures / shape and level of protection? Any picture or drawings would be appreciated.

Answer 2: We have provided plate dimensions and weight, please refer to Annex A 3.3.1 a and b. There is no relevant curvature. Level of protection is not required.

Question 3: In order to optimize discretion, would you accept ballistic panels that are chamfered on the edges?

Answer 3: Yes, as long as they meet all the requirements of the Request for Standing Offers.

Question 4: You have specified that the sample (Large) must be equal to or less than 32 oz. in weight. The protection area is very influential in the weight of the system. Is there a protection area specification?

Answer 4: The protection area is not specifically defined, in terms of dimensions, but is covered under Section 3.1 and 3.2 of Annex “A” – Requirement.

Question 5: Please confirm that the requirements outlined in Annex “A” – Requirement, 3.3.2 Labelling – “The soft body armour system must not include the manufacturer’s name anywhere on the system (carrier or panels)” is a requirement for the bid submission samples only and not for the products provided in call-ups against the Standing Offer. Our understanding is that the rules set out by the National Institute of Justice require the NIJ mark (meaning that the armour is certified) and very specific information including the Manufacturer’s name, address and contact information (among other items). Removing any of these items from the NIJ 0101.06 certified product label would result in being non-compliant with the NIJ.

Answer 5: The ballistic panels must be labelled, as per the NIJ standard, by the original manufacturer. It is expected (but not mandatory) that the manufacturer of the panels will differ from the manufacturer of the Soft Body Armour Systems. The name of the manufacturer of the Soft Body Armour System must not be anywhere on the carrier, and the name of the manufacturer of the Soft Body Armour System can only be on the ballistic panels if they are also the original manufacturer of the panels.
