1. QUESTIONS AND ANSWERS:

Question #30

With respect to the subject solicitation, would the Crown consider further extending the RFP closing date by 2 weeks? We have found communication and the data gathering and verification involved in the proposal development activities to be less efficient than normal due to the entire company working from home as a result of the Covid crisis and we require more time to complete our response.

Answer 30

The solicitation has already been extended twice for a total posting period of 7 weeks in response to the COVID situation. Due to operational requirements, the solicitation will not be extended for an additional 2 week.
