Article 2 (2.2) Submission Offers

ADD: Due to the impacts of the COVID-19 pandemic and to encourage physical distancing, the bid receiving units in Vancouver and Victoria will remain open but with limited staff and limited hours: Tuesdays, Thursdays and Fridays only, from 10:30 am to 2:30 pm (Pacific Daylight Time).

Due to limited staff available, bidders are strongly encouraged to transmit their bids electronically using the epost Connect service instead of any of the other methods of bid delivery that are available should the solicitation allow.

Question #1: What facilities are available? I.e. Are there fully equipped kitchens available?

Answer #1: No facilities available for preparation of food services (eg. Kitchen)

Question #2: Is the expectation to have a team at each location on standby?

Answer #2: Ideally we would like a company that could service each location, however, could be an individual company at each location. Requests would be on an as needed requirement, with timelines from company indicated for being able to process orders.

Question #3: What are the dining room facilities?

Answer #3: No facilities, would often be a work area, classroom or gym/parade square.

Question #4: Are hot boxes provided for dispersed meals?

Answer #4: Insulated Food Containers and Juice/Coffee urns are available for dispersed meals. They could be dropped with the vendor prior to the required event.
