THIS AMENDMENT IS RAISED TO RESPOND TO BIDDER QUESTIONS.

- Q100 Will Canada remove the ITB requirements from the procurement?
- A100 The ITB requirements form part of the mandatory and rated elements of the RFP for ADIS, and the Value Proposition was developed through market analysis and extensive industry engagement during the pre-RFP period.

'Best value' for Canada is considered to be a solution that offers the optimal balance between capability, cost and economic benefits. The ITB Policy is applied to both developmental, and COTS/MOTS procurements, and contributes towards 'best value' for Canada by ensuring that contractors generate economic outcomes for the dollars spent on defence-related procurements.

The low minimum Canadian content requirement for Direct work allows flexibility for bidders who wish to offer an ADIS solution that represents significant non-Canadian content, while the rated Value Proposition provides an incentive for competition.

Bidders are encouraged to explore opportunities to contribute positively to the economies in which they do business. Firms that operate on a global scale and in both the defence and commercial markets, offer opportunities to tap into their innovation, and the diversity of their resources and supplier networks to contribute to employment opportunities and growth in the local economy.
