Question #1

Do Unit prices for commercial unit parts need to be provided?

Answer #1

Refer to Annex B – Basis of Payment: “Unit rates for inspection includes replacement parts identified in the Statement of Work annual service inspection requirements”.

Only gaskets, burner nozzles, oil filters and air filters are to be included in inspection rates. All other parts needing to be repaired or replaced will be identified by the contractor and quoted separately.

Is there a list of makes and models for commercial units throughout CFB Halifax?

Answer #2

There is no list available at this time. Contractors are asked to provide unit rate pricing as referred to in question #1 based on their knowledge of standard commercial units.
