

No.	Question	Answer
1	We understand that the Government of Canada is, as much as possible, operating as "business as usual." However, other businesses are not able to operate "business as usual." Has the government considered extending the current method of supply by six months or even a year, rather than having all existing SA and SO holders take up valuable time to re-compete?	<p>Yes, Canada did consider extending the current method of supply, however, Canada was reassured that suppliers will continue to have the capacity of submitting their bid electronically through the Data Collection Component of CPSS.</p> <p>The Grandfather Certification is required if an existing supplier wishes to rely on the information already on file to demonstrate compliance with the streams and categories they already qualified for during the last re-competition and/or refresh.
