Solicitation Amendment No. 001 is issued to answer questions from the industry.

Questions and Answers

Question # 1: UNIITRAK Code 4C102, Item # 26, Assorted Mini Danish - Industry standard for this item would be 120 x 42 grams or 120 x 1 each based on your pack size, you require a 5040 unit case, is that correct?

Answer # 1: Yes that is correct, unit case of 5040 is required.

Question # 2: Section 6.4.3 specifies 3 additional 1 month extensions under the same conditions and rates and that a notification of the extensions would be provided 5 days from the expiry of the contract. In Annex B-1, the qualified offer is given an opportunity to rebid pricing for the option periods by submitting pricing no later than the 20th of the preceding month. Can you confirm that either the date for this tender is May 1 to July 31, 2020 and there be no optional periods or that the 3 additional 1 month extensions are the optional periods and rebid pricing can be submitted by the 20th of the month?

Answer # 2: The firm period of the Standing Offer is from May 01, 2020 to July 31, 2020. 3 additional 1 month extension periods are available for which price re-bid will be accepted and an amendment will be issued no later than 5 days for the extension and the price re-bid. For example for the first option period from August 01, 2020 to August 31, 2020 re-bid pricing must be provided by July 20, 2020.

Please Note: If a bid is being submitted via fax, please send the fax on the day of solicitation closing only.

It is strongly recommended to consider making bid submission via ePost.
