NOTE: Labeling of items going to the Distribution Centre must be exactly as indicated, if not, they will not be accepted.


11. MANDATORY DELIVERY DATE: On or before, but no later than August 28th, 2020

Provided prior approval by the Project Authority, partial deliveries will be accepted, but entire production must be delivered by **August 28th**, **2020**.


12. SHIPPING INSTRUCTIONS:

Skids

- a) Ship on non-returnable shipping skids measuring 48"
 wide by 42" deep, have three stringers with three blocks, each 48" in length;
- b) Each skid **must not** be higher than 54", including the skid;
- c) Each skid **must** have bottom boards and **must** be a brewery-type skid (four-way entry);
- d) Each skid **must** be shrink-wrapped;
- e) The material **must** be accessible by hand-held hydraulic pallet movers;
- f) Items shipped to 100-440 Coventry that are not on requested skids will not be accepted upon delivery.
