Question #5

Also in the Annex E Section 2 Errors and omissions Liability Insurance

This kind of insurance is usually applied to professional services such as Doctors / engineers etc. Is this an error & could this requirement be removed, as it has not been in the previous 3 contracts?

Answer #5: Annex E Section 2 will be deleted.

Question #6

Due to this covid19 situation some documents are taking longer to acquire than normal. Like insurance documents, Health Dept., Workmans compensation, Business Licenses. Will there be an extension to the closing date of this or can we provide documents as requested at a later date?

Answer #6: Status of tenders and timelines can be reviewed nearer to closing date to see if there is a requirement for extension.

Question #7

Given the current Covid-19 situation, it is very difficult to gauge the forthcoming impact on the supply line and predict what may be coming at us in terms of food costs which are already on the rise. Are there any contemplated allowances to provide for these unknowns? Or can we reflect a reasonable percentage range increase if required?

Answer #7: It is up to the vendor to provide requirements within the food guidelines. There are currently no additional allowances.

Question #8

Again, given the present Covid-19 scenario, the catering and food service industries are being particularly hard hit with regards to cash flow. Under the present circumstances will the DND/Government of Canada continue to take a negative view to the request for a contract deposit if required?

Answer #9: Advance payments will not be made for this requirement.
