Questions and Answers

Q26: With respect to amendment #2. Can you clarify the level of Medical Oversight that proponents are expected to provide for Paramedics? For example, we would expect that real-time physician consults regarding patient care would involve engagement with a local physician network. Can you confirm?

A26: The physician providing Medical Oversight for the Bidder will engage with the Nurse in Charge at the nursing station, as well as with Physicians as available. These Physicians will generally be working via teleconference from a remote location.

Q27: What the difference is between a Primary Care Paramedic and Community Paramedic? In our view, these are the same scope

A27: Paramedic designations vary in each province and have been referenced according to provincial regulatory bodies and colleges. The scope of practice is the same for Primary Care Paramedics and Community Paramedics.
