QUESTIONS AND ANSWERS

Question 21: In the Solicitation ITT Amendment 004, Answer 19 states: *“This solicitation is under clause: 2010A (2018-06-21) General Conditions - Goods (medium complexity), and no liability requirement is identified.”*

Does that mean the liability is unlimited? If the supplier causes any type of damages (breach, warranty, indemnification), can you tell us if the supplier is liable to an unlimited amount?

Answer 21: Yes, the liability is unlimited. Canada confirms that the solicitation documents contain no financial cap or limitation on the liability of the contractor.

Question 22: We are preparing our proposal to be submitted for the subject Bid and regarding the security clearance requirement, we currently have security clearance from the Canadian Industrial Security Directorate (CISD) with Public Works & Government Services Canada (PWGSC), and I wonder if this clearance is sufficient for the Bid requirement or not?

Answer 22: The Security Clearance is not required to be submitted with the suppliers bid submission.

The RCMP has a slightly different security clearance process than what is identified by the Canadian Industrial Security Directorate (CISD) with Public Works & Government Services Canada (PWGSC).

The Security Clearance requirement will only be requested from the supplier with the Lowest Compliant Financial Bid Proposal, that meets the Technical requirements of the solicitation.
