Amendment 1 is raised to publish questions and answers:

Q1. In regards to the above solicitation, would a concurrently adjustable mechanism be acceptable under the Rotary Chair category for item #4?

A1. The tilt mechanism for chair #C-4 must be Unison.

Q2. It seems that the CA has grouped the entire product offerings in one delivery table and one installation table. What if we don't have a product for one of those tables? Should there be a separate D&I and Evaluation tables for each of the product tables, technically?

A2. No. All five chairs have been itemized from 1 through 5 (1 - 5). For example, if the Bidder does not have product for the chair at line item 2 of the Product Table(s), then in the Delivery and Installation tables the Bidder will need to indicate NIL or \$0.00 at line items 2.

Q3. Chair #2 in the above mentioned RFB has a GOCUID# that does not match the description. Please Confirm if the GOCUID# should be BFCWAWSNUDF instead.

A3. The GOCUID should read BFCWAWSNUDF. Casters for carpet are required for chair #C2.

No substitutions will be accepted for chair #C2.
