Amendment No. 002 is being issued to address the following Questions and Answers:

Q1. Will any limitations on liability be accepted?

A1: Limitation of Liability is not accepted and will not be included.

Q2: What is the difference between the date of submission and date of deliverables?

A2: Date of submission is related to the closing date and time of the Request for Proposal solicitation. Bidders submitted after this date/time will not be accepted. Date of Deliverables is the completion date for all deliverables described in the tender document, which will form part of any issued contract. Reference Section 6.4.2 – Delivery Date in the Request for Proposal document.

Q3. Helium for purge: what state will the trailer be in prior to filling? Nitrogen service (post maintenance)? or in helium service (if yes what pressure)? Please provide best available information to help with the volume required for the purge.

A3: The trailer tubes were purged with nitrogen following the most recent 10-year maintenance event. The service provider did not provide measurements but stated that their pump is capable of reaching 29" of mercury or better and typical achieve moisture levels below 1:1,000,000.

Q4: The agreement is to be valid until March 31, 2021, will there be other deliveries required during the duration of the agreement other than the one described in the bid document (2,800 m3)?

A5: Canada will have the option to purchase services related to purging of the tubes, a purchase release valve and a contingency amount of helium described at Annex B – Basis of Payment, Section 2. Optional Deliverables.

Q5: Do consequences of COVID-19 fall within the definition of Excusable Delay?

A5: Yes. However, suppliers considering proposing a bid proposal are strongly encouraged to consider raising any issues or questions with the Request for Proposal (including delivery date) during the solicitation process and prior to the bid closing date and time. The Request for Proposal will have been tendered for 40+ days at the time of bid closing. Suppliers have been aware of COVID-19 throughout this period and the impact it will have on their ability to deliver in accordance with the solicitation.
