1A - COLLABORATIVE MEETING TABLE (WITH POWER) (ITEM 1A & 1B MUST BE FROM SAME BIDDER, MANUFACTURER AND SERIES)

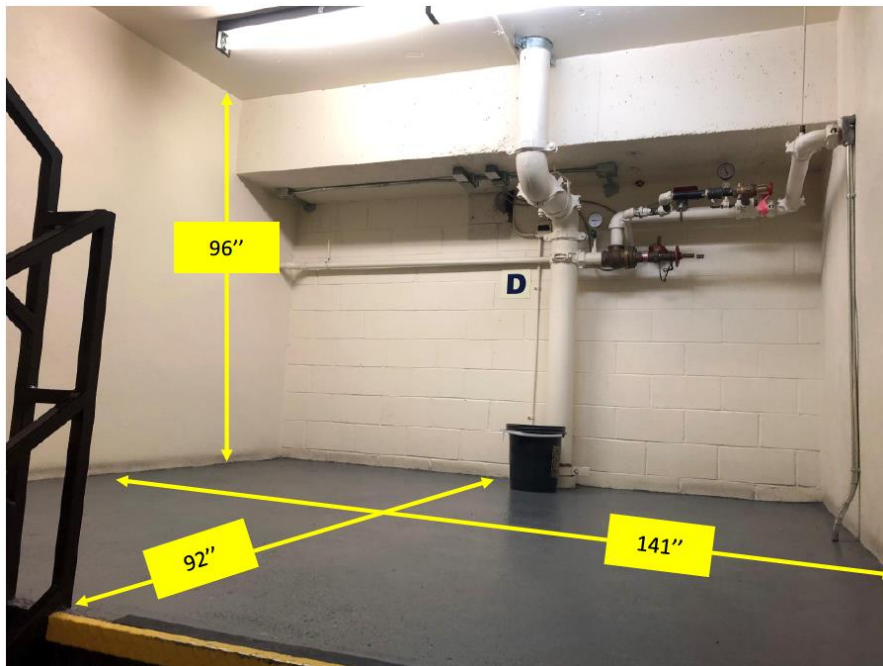
- Description:
 - Must be a rectangular large meeting table with table top power module and open storage feature
 - Must accommodate collaboration of approx. 10-14 people
- Dimensions:
 - Must be 2997mm - 3048mm W x 1524mm D x 914mm – 991mm H (118-120" W x 60" D x 36-39" H)
 - *****Due to the COVID19 situation, a mandatory site visit will take place after contract award only. Dimensions may slightly change following the site visit to accommodate special delivery needs.**
- Construction:
 - Table top must be one piece with rounded corners (not squared)
 - Must have power module and open storage feature to be centrally located on table top and flush with surface.
 - Power module must have a minimum of four (4) electrical outlets and four (4) USB outlets
 - Open storage feature must accommodate small stationery (i.e.: markers, pens, sticky notes, remotes, etc.)
 - Table must have four (4) angled legs (no end gables or base)
 - Table must accommodate counter height stools on all four sides
 - Horizontal cable management must be provided with the table
- Finishes:
 - Table top surface must be High Pressure Laminate
 - Center power module and open storage feature must be of plastic, metal or high pressure laminate finish
 - Legs must be painted or brushed metal
- Standards:
 - Deflection of tables must meet the acceptable levels as described in CAN/CGSB 44.227 in the following manners:

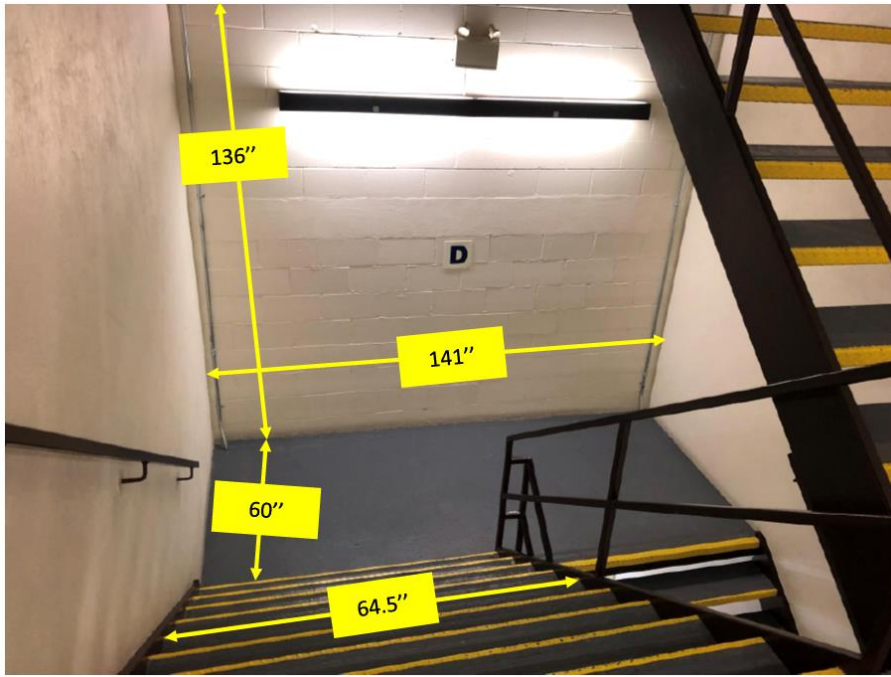


Escalier "D" / Staircase "D"

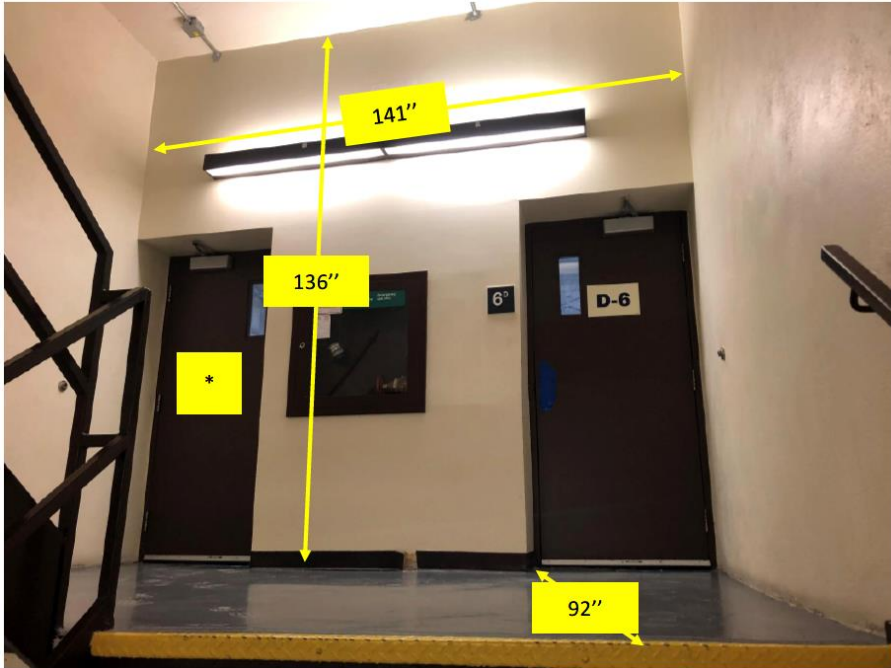
← Plateformes d'escaliers du rez-de-chausée au 3^e étage / Staircase landings from ground floor to 3rd floor.
