AMENDMENT 001

This Amendment 001 is raised to address a bidder's request.

Request: Exception to 4.1.1.1 (b) Solicitation No. M9062-205603/A

We would like to submit a proposal for Solicitation No. M9062-205603/A ERT Command Centre but would request a partial exemption from 4.1.1.1 (b) which requests "Minimum of five (5) references on similar police emergency vehicle builds which they have completed within the last five (5) years".

We have not built trailers specifically for police organizations however we see nothing in the technical specifications outside of our capabilities. We have previous experience building industrial command centers and combination office and working trailers.

Furthermore, we are a Canadian company, we are federally certified by Transport Canada and we build superior products.

In addition, it is our opinion this requirement gives preferential treatment to our competitors and we would like an opportunity to enter this market. Providing references from our satisfied clients whom we have delivered similar products to is not an issue. Therefore, we would request this be removed from the bid requirements.

Thank you for your attention to this request.

Answer:

In order to maintain the required technical expertise in our custom-built critical incident vehicles we are not in a position to eliminate our requirement for references of a minimum of 5 similar police emergency vehicle builds within the last 5 years. RCMP demands that we use proven police vehicles from vendors familiar with the operational requirements of the RCMP.
