Question 1: Is there an illustration, technical drawing or photo of the antennas required corresponding to the tech specs shown in the RFP?

Answer 1: We are unable to share any technical drawings as they are proprietary to the manufacturers.

Question 2: Is this requirement for a newly designed VHF antenna for use in RCMP TX/RX communication repeater stations in its network, or are the tech specs shown for VHF antennas currently in use?
