AMENDMENT 001

This amendment is to post a series of questions and answers and to replace the boxed lunches details attachment.

QUESTION 1:

What is the shelf life required for the lunch boxes? I can't find the information, 14 days? Regarding Menu 11, the 2 sandwiches in item B, the sandwich with salad can be packed fresh with a shelf life of a few days, not under «modified atmosphere» because the salad does not retain its shape and texture.

ANSWER 1:

The minimum shelf life in «modified atmosphere» is 14 days. However, if salad is requested, the maximum will be 7 days.

QUESTION 2:

What are the 2 HALAL sandwiches requested in Menu 10, so we can establish a price?

ANSWER 2:

The 2 HALAL sandwiches requested are Roast Beef sandwich and Egg sandwich.

QUESTION 3:

Is there any instruction for the boxes? Size, number of boxes per case.

ANSWER 3:

These instructions were specified in the old versions of standing offers and we have always kept the same. White boxes of approximately 9 13/16 x 7 1/16 x 3 9/16, 12 boxes per case.

QUESTION 4:

The HACCP certification for meat and poultry for the sandwich factory is indeed a requested certificate? And the one for fish and seafood? I don't see the application in the Certification section of Part 5.

ANSWER 4:

It is not required. Usually, the poultry and meat products come from HACCP plants.

QUESTION 5:

For the 2nd sandwich of the Diner 9 menu, line B, there is the Chicken Salad Sandwich in the French version and the English version is the Egg Sandwich, which one is the right one?

ANSWER 5:

Chicken Salad (See Details paniers-repas – Boxed lunches details – Version 001).
