Amendment 2

This amendment is raised to provide answer to questions.

QUESTIONS: 1

Are we able to use a different material for the pre-award samples? The pre-award samples will use two different colors, the pre-award sample will still allow examination for dimensional accuracy and workmanship. The material used during production will meet the required specifications.

ANSWERS: 1

A pre-award samples cannot be made using a different material. A pre award samples can be done in any colour(s), providing that the fabric itself meets the outlined technical performance specified in the Annex A.

QUESTIONS: 2

The acceptable material for production is stated to be OUTER LAYER: COTTON or LINEN or NYLON/COTTON or BLEND, LIGHTWEIGHT, 170 g/m² +/-5%. There are different levels of Nylon / Cotton blend and different types of Nylon. Are there any additional details that can be offered?

ANSWERS: 2

Yes, the material for production to be 50% Cotton/50% Nylon blend (tolerance range of 45-55% for both Cotton and Nylon)

All other terms and conditions remain unchanged.
