2. QUESTIONS & ANSWERS:

Q2. Regarding the above noted RFP, R5 states that: The Bidder should demonstrate that its proposed senior resource has a minimum of five (5) years' experience within the last ten (10) years in the clothing and footwear industry, specifically in supply chain management, and in DND/CAF analysis. This seems unusually restrictive and will no doubt discourage bidders. Would you consider removing this criterion or broadening it to read: five (5) years' experience in supply chain management?

A2. The scoring methodology in rated criterion R5 will be amended as follows:

10 pts = Very Good: proposal demonstrates that its proposed senior resource has a minimum of five (5) years' experience within the last ten (10) years in the clothing and footwear industry, the supply chain management and the DND/CAF analysis.

5 pts = Good: proposal demonstrates that its proposed senior resource has a minimum of five (5) years' experience within the last ten (10) years in either the clothing and footwear industry, the supply chain management or the DND/CAF analysis.

0 pts = Incomplete: proposal doesn't demonstrate that its proposed senior resource has experience in the clothing and footwear industry or the supply chain management or the DND/CAF analysis.
