This solicitation amendment 003 is raised to make the following changes;

1. *Answer questions raised by the Industry;*
2. *Modify Annex A- Statement of Requirement, article 3. Requirements, sub-article 3.1 Contents of Crew Leader Office Supply Kits, Office Supplies Kit A.*

1. Answer questions raised by the Industry;

Question 001:

Under Item 3 of section 4.1.3.b (Evaluation of Price): "Although Canada reserves the right to award the Contract either on an FOB plant or FOB destination, Canada requests that Bidders provide prices FOB their plant or shipping point and FOB destination. Bids will be assessed on an FOB destination basis." Should Bidder submit a quote based on the FOB destination basis only or quotes using both FOB bases?

Answer 001:

As bids will be evaluated on an FOB destination basis, Canada requests that Bidders submit pricing using FOB destination. Financial bids must be in Canadian dollars, Delivered Duty Paid (DDP) at destination, Incoterms 2000, Canadian Custom Duties and Excise Taxes included where applicable and Applicable Taxes extra.

Question 002:

For WESTCOTT KLEENEARTH 7" ANTIMICROBIAL STRAIGHT SCISSORS with Product No: 15582, we noted most suppliers have this product with same Product No without the "Antimicrobial" description. Kindly confirm if we can supply a product without this descriptive term or this term is a definitive description of this product?

Answer 002:

Yes, a product without this descriptive term is acceptable.

Question 003:

For PAPERMATE INKJOY 300ST BALLPOINT PENS, 0.7MM, BLACK with Product No: 1959314, we noted difficulty from suppliers in quoting for this Product No with the exact product description. We got responses with the following product description for Product No 1959314: PaperMate Inkjoy Gel Pens, Retractable, Medium 0.7mm, Black. This is not exactly as specified. We, however, received a response of a product with the description "Paper Mate Inkjoy 300 Extra-smooth Ballpoint Pen 0.7mm, Black" with a different Product No 1951374 that seems to have a similar description to your specification. Kindly reconfirm the accuracy of the required Product No and the associated product description.

Answer 003:

Continue with product no. 1959314 PaperMate Inkjoy Gel Pens, Retractable, Medium 0.7mm, Black - even if the product description varies slightly.

However, we saw another gel pen with Product No 46830 having the following product description: "Zebra Sarasa Retractable Gel Pen, Red, Medium 0.7mm (type of item 2 on the attached list). I have attached a list & pictures of all Gel Pen from Zebrapen Canadian website for reference. Kindly re-clarify on the exact gel pen required to supply.

Please continue with product no. 22230-0.

Question 005:

For WESTCOTT® 30CM/12" CLEAR ACRYLIC RULER with Product No 85030, we noted a similarly described product on "Westcott.com" website with Product No: 10562, as well as different Product Nos e.g. 38258 and 20020-0 for a similar product from different suppliers. Can we buy any of these similarly described products?

Answer 005:

Yes, as long as the product is similarly described and the price does not exceed our initial product.

Question 006:

In regards to this solicitation, Amendment 002, Q&A #002: Product #54132 is replaced with #51056 on the Office Supplies Kit B. As the product/product codes are identical in both Kits A & B, would this also apply to the Writing pads in Kit A? Please advise.

Answer 006:

Yes, this would also apply to writing pads in Kit A, same notepad in both kits.
