QUESTIONS	ANSWERS
<p>Q6. Could you please elaborate on the motivation for ECCC to look for an "internal" crowdsourcing platform instead of an "external" crowdsourcing platform or a combination of both?</p>	<p>A6. The GC had set a precedent in 2019 with phase 1 of a pilot project that allowed science and technology-related challenges to be posted on private sector crowdsourcing platforms that were open to anyone around the world to solve (external). This RFI is designed to facilitate phase 2 of the pilot project whose objective is to ease public servants into adopting crowdsourcing by using a platform that is only visible to their public servant colleagues. The idea is to remove any potential stigma that staff may feel about publically admitting they cannot solve a given problem. If staff become comfortable using the "internal" platform and if it proves useful, they may then become less reticent to using an "external" platform open to all. In other words, an internal platform will be used in this pilot as a tool for acculturation for crowdsourcing generally.</p>
<p>Q7. While this RFI is specific to internal solutions, would the government be open to expanding the use of vendors for external solutions?</p>	<p>A7. The GC already allows staff to post science and technology-related challenges on private sector crowdsourcing platforms which are open to anyone around the world to solve (i.e. external). However, for the purposes of the pilot project being contemplated in this RFI, ECCC is specifically looking for information regarding purchasing SaaS for use as an internal crowdsourcing platform.</p>
<p>Q8. Is there an opportunity for a hybrid crowd option? Would the government be open to internal and external solvers working on their challenges?</p>	<p>A8. Yes, ECCC would be open to internal and external solvers working on their challenges in the future. However, for the purposes of the pilot project being contemplated in this RFI, ECCC is specifically looking for information regarding an internal platform.</p>
<p>Q9. Are there any procurement vehicles/acquisition mechanisms that currently exist to procure external crowdsourcing solutions?</p>	<p>A9. As far as ECCC is aware, there are currently no procurement vehicles or acquisition mechanisms in place to procure external crowdsourcing solutions.</p>
<p>Q10. What is the volume of crowdsourcing projects ECCC expect to run?</p>	<p>A10. It is unknown at this time what volume of crowdsourcing projects ECCC will run.</p>
<p>Q11. Could you please elaborate on outputs or deliverables that ECCC are seeking from their crowdsourcing challenges? Examples, white papers, code or other?</p>	<p>A11. Any challenge type that is solvable through crowdsourcing and is within the scope and mandate of ECCC is a potential deliverable. This includes scientific and technical solutions, web site design, infrastructure design, coding, etc.</p>
<p>Q12. Could ECCC please elaborate on what a policy-related challenge might look like by providing an example of one?</p>	<p>A12. An example of a policy-related challenge that ECCC might run would be: What governance structures currently exist around the world that may be suitable for water management in Canada.</p>
<p>Q13. Does the government expect to be able to use the SaaS independently or with help from the vendor?</p>	<p>A13. It is unknown at this time whether ECCC would require help from the vendor to use the SaaS. This would depend on the complexities and attributes of platforms and value of vendor assistance.</p>

QUESTIONS	ANSWERS
<p>Q14. What is the budget or budget range intended for the typical crowdsourcing project you envision?</p>	<p>A14. The budget intended for a typical crowdsourcing project is unknown at this time. It will be informed by this RFI.</p>
<p>Q15. Does ECCC anticipate vendors to work on site or would remote work be acceptable?</p>	<p>A15. It is unknown at this time whether ECCC would require vendors to work on site or whether remote work would be acceptable. Complexities and attributes of platforms and value of vendor assistance need first to be showcased: whatever works best and is the most efficient and effective will be employed.</p>
<p>Q16. Can you elaborate on the Disaster Recovery Plan requirement? Is this referring to a platform failure?</p>	<p>A16. The Disaster Recovery Plan involves a set of policies, tools and procedures to enable the recovery of data loss and disruption to client activity or loss of Canada data and to the continuation of vital technology infrastructure and systems following a natural or human-induced disaster. Canada would also like to know if a data backup plan for data recovery would be included in your Service Level Agreement, if not, would any additional investment be required?</p>
