The purpose of this amendment is to answer questions from suppliers.

Question 14

Please confirm if we can suggest a different sewing process for the mask without changing fabric estimate.

Please note that we have tried 5 different mock ups by following your instructions but it will be very difficult to have the pleats match the two sides and the thickness of all fabrics will make it very difficult to have straight edge stitching.

Answer 14

The manufacturer may use their own manufacturing processes as long as the design and size of the mask meets the specification.

Question 15

Does the sample have to be received by May 28 or is date stamped by post office May 28 acceptable?

Answer 15

Samples must be physically received by 2pm on May 28, 2020 at the address specified under 4.1.1.1.1.

Question 16

Could you please clear the following doubts for me regarding the Packaging of the masks:

- 1) Is it okay if stick a printed label on the poly bag in which we put the masks?
- 2) Is there a specific font size and font style we need to print on the label in?
- 3) Do we have any labels to be attached to the masks as well?
- 4) Do you have any specific size of the poly bag in which we deliver the masks?

Answer 16

- 1) Yes a printed label on the poly bag is acceptable.
- 2) Arial font is preferred 10 pt.
- 3) No, labels are only needed on poly bag.
- 4) An appropriate sized poly bag that easily fits four masks is acceptable.

All other terms and conditions remain unchanged.
