This solicitation amendment 004 is raised to make the following changes;

- 1. Answer questions raised by the Industry;**

Question 001:

Would Canada please clarify or reconsider the quantity requirement:

Item 2 - White eraser 526 B20

These are sold in boxes of 20 erasers. Is the requirement for 18 boxes of 20 erasers (Kit A) and 26 boxes of 20 erasers (Kit B) or single erasers? If the requirement is for single erasers, would Canada change the requirement to full box lots to prevent any damages in shipping? Full box lots would also help reduce the labour costs of unpackaging and repackaging which would ultimately be a savings to Canada.

Item 3 - Yellow highlighter 25025

These are sold in boxes of 12 highlighters. Is the requirement for 2 boxes of highlighters or 2 single highlighters? If the requirement is for singles, would Canada change the requirement to full box lots to prevent any damages in shipping? Full box lots would also help reduce the labour costs of unpackaging and repackaging which would ultimately be a savings to Canada.

Item 4 - Permanent black marker 38201

These are sold in boxes of 12 markers. Is the requirement for 2 boxes of markers or 2 single markers? If the requirement is for singles, would Canada change the requirement to full box lots to prevent any damages in shipping? Full box lots would also help reduce the labour costs of unpackaging and repackaging which would ultimately be a savings to Canada.

Item 5 - Pen, ballpoint black 1959314

These are sold in boxes of 12 pens. Is the requirement for 42 boxes of pens (Kit A) and 60 boxes (Kit B) or single pens? If the requirement is for singles, would Canada change the requirement to full box lots to prevent any damages in shipping? Full box lots would also help reduce the labour costs of unpackaging and repackaging which would ultimately be a savings to Canada.

Item 6 - Ball point pen - red 22230

These are sold in boxes of 12 pens. Is the requirement for 3 boxes of pens or single pens? If the requirement is for singles, would Canada change the requirement to full box lots to prevent any damages in shipping? Full box lots would also help reduce the labour costs of unpackaging and repackaging which would ultimately be a savings to Canada.

Item 7 - Pencil sharpener - 51010

These are sold in boxes of 20 pencil sharpeners. Is the requirement for 1 box of sharpeners or a single sharpener? If the requirement is for singles, would Canada change the requirement to full box lots to prevent any damages in shipping? Full box lots would also help reduce the labour costs of unpackaging and repackaging which would ultimately be a savings to Canada.

Item 8 - Pencils HB 132 46CB12

These are sold in boxes of 12 pencils. Is the requirement for 42 boxes of pencils (Kit A) and 60 boxes (Kit B) or a single pencils? If the requirement is for singles, would Canada change the requirement to full box lots to prevent any damages in shipping? Full box lots would also help reduce the labour costs of unpackaging and repackaging which would ultimately be a savings to Canada.

Item 9 - Post-it Notes R330-6SSCY-C

These are sold in packages of 6 post it note pads. The requirement is shown as 5 pads. Would Canada change the requirement to a package of 6 pads to prevent any damages in shipping? Full package lots would also help reduce the labour costs of unpackaging and repackaging which would ultimately be a savings to Canada.

Item 13 - Red file folders 65161

These are sold in boxes of 100 folders. Please update the total items required to 100 items/1 box for both kits.

Item 14 - Clear packing tape 3710-6PK

These are sold in packages of 6 rolls of tape. Would Canada change the requirement to a package of 6 rolls to prevent any damages in shipping? Full package lots would also help reduce the labour costs of unpackaging and repackaging which would ultimately be a savings to Canada.

Item 15 - Paper clips 5050572380

These are sold in packages of 10 box of 100 clips. Would Canada change the requirement to a package of 10 boxes to prevent any damages in shipping? Full package lots would also help reduce the labour costs of unpackaging and repackaging which would ultimately be a savings to Canada.

Answer 001:

Item 2- White eraser 526 B20

The quantities required are in single units. The requirement for Kit A has been changed to a full box lot (20 erasers). However, Kit B will remain the current quantity of 26 (e.g. 1 box + 6 individual erasers).

Item 3- Yellow highlighter 25025

The quantities required are individual units (i.e. 2 highlighters, not 2 boxes). This quantity will not change.

Item 4- Permanent black marker 38201

The quantities required are individual units (i.e. 2 markers, not 2 boxes). This quantity will not change.

Item 5- Pen, ballpoint black 1959314

The quantities required are individual units (42 and 60 pens, not boxes) (e.g. 3 boxes + 6 individual pens (42) and 5 boxes of pens (60). This quantity will not change.

Item 6- Ballpoint pen - red 22230

The quantities required are individual units (i.e. 3 pens, not 3 boxes). This quantity will not change.

Item 7 - Pencil sharpener – 51010

The quantities required are individual units (i.e. 1 sharpener, not 1 box). This quantity will not change.

Item 8 - Pencils HB 132 46CB12

The quantities required are individual units (42 and 60 pencils, not boxes) (e.g. 3 boxes + 6 individual pencils (42) and 5 boxes of pencils (60). These quantities will not change.

Item 9 - Post-it Notes R330-6SSCY-C

The requirements have been changed to a packages of 6.

Item 13 - Red file folders 65161

Canada requires 25 items/1 box. If the file folders don't come in boxes of 25, we only want 25 units per kit. The boxes of 100 must be divided into units of 25.

Item 14 - Clear packing tape 3710-6PK

Requirements to remain the same – 2 rolls per kit.

Item 15 - Paper clips 5050572380

Requirements to remain the same – 1 box per kit.

Question 002:

For item 9 Post-It notes, Canada has selected the pop-up style product which should be used in a post it note dispenser. Would Canada consider adding a dispenser to the kit list?

This image demonstrates the fan-fold style used for dispensers.



Alternatively we would suggest replacing the pop-up style note with product 654-5SST-C which is a package of 5 super sticky Bora Bora Post-It notes 3" X 3" with 30% post-consumer waste, or 654-12SSCY-C which is a package of 12 yellow super sticky 3" X 3" Post-It notes.
