AMENDMENT 009

This Solicitation amendment (009) is raised to 1) extend the solicitation closing date and 2) revise a clause in the contract clauses.

- 1) Canada is extending the solicitation closing date from May 29, 2020 to June 30, 2020 14:00 Eastern Daylight Time (EDT).
- 2) Delete articles 7.5.3 and 7.5.4 in **Clause 7.5 Warranty** and replace the articles by the following:

7.5 Warranty

- 7.5.3 The Work or any part of the Work found to be defective or non-conforming will be returned to the Contractor's plant for replacement, repair or making good. However, when in the opinion of Canada it is not expedient to remove the Work from its location, the Contractor must carry out any necessary repair or making good of the Work at that location. In such cases, the Contractor will be paid the fair and reasonable Cost (including reasonable travel and living expenses) incurred in so doing, with no allowance for profit, less an amount equal to the Cost of rectifying the defect or non-conformance at the [Designated Single Point Delivery \(DSPD\) specified by the Contractor at clause 7.25.](#)
- 7.5.4 Canada must pay the transportation cost associated with returning the Work or any part of the Work [the Designated Single Point Delivery \(DSPD\) by the Contractor pursuant to subsection 7.5.3.](#) The Contractor must pay the transportation cost associated with forwarding the replacement or returning the Work or part of the Work when rectified to the delivery point specified in the Contract or to another location directed by Canada.

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED
