AMENDMENT 002

The Solicitation Amendment is raised to provide answers to questions raised by bidders as follows:

Question 1

Colour Swatch: As there is no Pantone colour code for the green provided, and if this is a specific green colour that would require a custom minimum order, may we please obtain a sample of the colour swatch green.

Answer 1

The specific green is a custom order colour. At this time we do not have swatches available for all bidders. A colour swatch will be provided to the successful bidder at contract award.

Question 2

Dome Fasteners: Scovill does not offer any powder coated finishes on their snaps. All their snaps are plated black-oxide, government black, which is per all US military specs. Would a plated black-oxide finish be an acceptable equivalent to the powder coated finish?

Answer 2

Plated black-oxide dome fasteners meeting US military specifications are an acceptable equivalent.

Question 3

Shell Material: This is a question more related to the thickness of the yarn used to make the fabric as oppose to the fabric's performance. Our shell material can meet all the 1000 denier requirements in Table I with one exception - the yarn count is at 13x11 instead of 18x13, is this acceptable?

Answer 3

A 1000 denier shell material with an alternate yarn count will be acceptable provided that all other performance requirements outlined in Table I of the specifications are met.

All other terms and conditions remain the same.
