This solicitation amendment is raised to:

- 1. Address the questions submitted during the solicitation period as per RFP; and
- 2. Amend the RFP.

1. QUESTIONS AND ANSWERS

- **Q1.** Who is the current survey tool provider?
 - **A1.** The current survey tool provider is OutsideSoft Solutions Inc.

See Tender Award Notice PW-15-00705778. https://buyandsell.gc.ca/procurement-data/award-notice/PW-15-00705778-001.

- Q2. How many respondents/completes did CRA do last year? Over how many surveys?
 - **A2.** We had approximately 500,000 completes over the last year from roughly 75 surveys.

Please note that all data regarding prior usage by CRA is provided to bidders purely for information purposes, and to assist them in preparing their bids. This represents the best information currently available to CRA however, CRA does not warrant or represent that this data is complete or free from errors. Additionally, the inclusion of this data in this solicitation does not represent a commitment that CRA's future usage will be consistent with this data. It is provided purely for informational purposes.

- Q3. Is there an expected budget for the all-inclusive annual rate?
 - **A3.** We do not have an expected budget.
- **Q4.** Considering the recent stay at home directives in Quebec and most of the country, will you consider accepting electronic / email submissions?
 - A4. When responding, the proposal MUST be sent by fax or using an electronic/online -fax service to 418-562-3058. Bidders should keep a copy of their fax transmission report for record keeping purposes.

ONLY ELECTRONIC BIDS WILL BE ACCEPTED. Due to the COVID-19 situation, the delivery of a physical (paper) proposal is not considered to be practical and therefore physical proposals will not be accepted.

Q5. Regarding M01:

what is an appropriate supporting document detail for this? is certifying that we do protect against these threats enough?

A5. This requirement has been removed from Appendix 1: Mandatory Criteria. Please note that this criterion remains mandatory, but has been removed from Appendix 1.

Q6. Regarding M02:

Do you have an estimate of needed storage space for all such content over a year? Over last contract period?

How much is collected data vs images/videos?

Is CRA open to archiving older projects?

A6. We do not have an estimated amount of storage space.

Please see A2 above for number of surveys and completes from last year.

95% is collected data vs images/videos.

CRA is open to archiving older projects. CRA must have access to all content created throughout the duration of the contract.

Q7. Regarding R23:

May you provide some clarification on Text Analysis? Is this for open end coding or other uses? What is the end objective?

A7. Basic Text Analysis refers to the frequency counts of words, producing a word cloud based on frequencies and the ability to remove "stop words" so they are not included in the count within the tool for a quick snapshot of the open text responses.

The objective is to be able to do open end coding for further and more advanced text analysis outside of the tool.

- **Q8.** Regarding the model contract in section 6 of the RFP section 6.15: if we accept 2 of the 3 payment methods, is that acceptable?
 - **A8.** No. The payment method will be selected at Canada's discretion as per Article 6.15 of the Model Contract.

- **Q9.** Typically these are managed by the number of survey responses (vs the # of users). What is your estimated number of survey responses over the last 3 years? What is your projected growth for the next year?
 - **A9.** We would estimate about 500,000 completes per year, with roughly a 10% growth for next year.

This represents the best information currently available to CRA however, CRA does not warrant or represent that this data is complete or free from errors. - Q10. R4 says WCAG 2.0 AAA vs in Annex A 4.1.1 it says AA. Which is it?
 - A10. Annex A indicates that the survey tool must meet the WCAG 2.0 at the AA level. All requirements found in Annex A: Statement of Requirement are mandatory. R04 indicates that the Online Survey Tool should meet WCAG 2.0 at the AAA level. The requirements found in Appendix 2: Point Rated Criteria are not mandatory, but point-rated. Please review Part 4 Evaluation and Selection of the RFP for further clarifications.

- **Q11.** Can you provide 3-4 use cases of the types of surveys?
 - **A11.** 1 Satisfaction surveys for users to provide their feedback after using our online portals.
 - 2 Employee Surveys to gauge satisfaction and gain insight to improve our internal programs and services.
 - 3 Evaluation and Feedback on courses or programs a survey sent to individuals after participating in a program or course.
- **Q12.** What tools are you currently using?
 - **A12.** Please see A1 above.
- Q13. R1 We noticed that this was NOT a mandatory requirement (hosting servers security in Canada). We would recommend that this is mandatory.

You will likely have use cases / questions in the future that will deal with Protected A & B applications.

In the event that you want to conduct a type of survey that has sensitive information, etc, you will not be able to unless this is in a Canadian Protected B environment.

- A13. Thank you for your recommendation. We do not require a protected environment for our data as the nature of Public Opinion Research (POR) is to collect the information anonymously. We recognize the importance of the security and safety of any type of information, which is why we have provided points to Bidders if their servers are hosted in Canada.
- Q14. In light of the effects of COVID-19, will CRA remove the requirement for hard copy submissions and mailing of any responses? Can vendors respond via email?
 - **A14.** Please see A4 above.
- **Q15.** Please confirm CRA wishes to see the responses organized in the following manner:

Section I: Technical Bid will include the following:

In their technical bid, bidders should demonstrate their understanding of the requirements contained in the bid solicitation and explain how they will meet these requirements. Bidders should demonstrate their capability in a thorough, concise and clear manner for carrying out the Work.

The technical bid should address clearly and in sufficient depth the points that are subject to the evaluation criteria against which the bid will be evaluated. 2.1 Mandatory Requirements

Wherever the words "shall", "must" and "will" appear in this document or any related document forming a part hereof, the item being described is a mandatory requirement.

Failure to comply or demonstrate compliance with a mandatory requirement will render the bid non-responsive and the bid will receive no further consideration.

2.2 Standard Instructions, Clauses and Conditions A0000T (2012-07-16)

2.2.1 Revisions to Standard Instructions 2003

Standard Instructions - Goods or Services - Competitive Requirements 2003 (2019-03-04) are revised as follows.

Section 01 titled "Integrity Provisions—Bid", is deleted in its entirety and replaced with the following:

- 1. The Supplier Integrity Directive (SID) dated May 24, 2016, is incorporated by reference into, and forms a binding part of the bid solicitation. The Bidder must comply with the SID, which can be found on the Canada Revenue Agency's website at https://www.canada.ca/en/revenue-agency/corporate/about-canada-revenue-agency-cra/procurement-cra/supplier-integrity-directive.html
- 2. Under the SID, charges and convictions of certain offences against a Supplier, its affiliates or first tier subcontractors, and other circumstances, will or may result in a determination by Public Works and Government Services Canada (PWGSC) that the Supplier is ineligible to enter, or is suspended from entering into a contract with Canada. The list of ineligible and suspended Suppliers is contained in PWGSC's Integrity Database. The SID describes how enquiries can be made regarding the ineligibility or suspension of Suppliers.
- 3. In addition to all other information required in the bid solicitation, the Bidder must provide the following:

- 4. Subject to subsection 5, by submitting a bid in response to this bid solicitation, the Bidder certifies that:
 - a. it has read and understands the SID (https://www.canada.ca/en/revenue-agency/corporate/about-canada-revenue-agency-cra/procurement-cra/supplier-integrity-directive.html)
 - b. it understands that certain domestic and foreign criminal charges and convictions, and other circumstances, as described in the SID, will or may result in a determination of ineligibility or suspension under the SID;
 - c. it is aware that Canada may request additional information, certifications, and validations from the Bidder or a third party for purposes of making a determination of ineligibility or suspension;
 - d. it has provided with its bid a complete list of all foreign criminal charges and convictions pertaining to itself, its affiliates and its proposed first tier subcontractors that, to the best of its knowledge and belief, may be similar to one of the listed offences in the SID;
 - e. none of the domestic criminal offences, and other circumstances, described in the SID that will or may result in a determination of ineligibility or suspension, apply to it, its affiliates and its proposed first tier subcontractors; and
 - f. it is not aware of a determination of ineligibility or suspension issued by PWGSC that applies to it.
- 5. Where a Bidder is unable to provide any of the certifications required by subsection 4, it must submit with its bid a completed Integrity Declaration Form, which can be found at Declaration form for procurement.
- 6. Canada will declare non-responsive any bid in respect of which the information requested is incomplete or inaccurate, or in respect of which the information contained in a certification or declaration is found by Canada to be false or misleading in any respect. If Canada establishes after award of the Contract that the Bidder provided a false or misleading certification or declaration, Canada may terminate the Contract for default. Pursuant to the SID, Canada may also determine the Bidder to be ineligible for award of a contract for providing a false or misleading certification or declaration.

Section 02 titled "Procurement Business Number", is hereby deleted in its entirety and replaced with:

Section 05 titled "Submission of Bids", paragraph 2 (d) is deleted in its entirety and replaced with the following:

(d) send its bid by fax or using an electronic/online-fax service only to the telephone number specified in the solicitation in Section 2.3.

Section 05 titled "Submission of Bids" paragraph 4, delete sixty (60) days and replace with one hundred and twenty (120) days.

Section 06, titled "Late Bids", clause 6 is deleted in its entirety and replaced with the following:

"CRA will return or delete bids delivered after the stipulated solicitation closing date and time, unless they qualify as a delayed bid as described in section 07.

For late bids submitted either by fax, or by an electronic/online fax service, the physical bid will not be returned. Rather, late bids submitted in this manner will be deleted. Records will be kept documenting the transaction history of all late bids submitted.

Section 07 titled "Delayed Bids", all references to "PWGSC" are hereby deleted and replaced with "CRA". In addition paragraph 1(b) is deleted in its entirety and replaced with the following:

b. The only piece of evidence relating to a delay in the electronic/online fax service that is acceptable to CRA is the official time stamp of when the file was received by CRA on the electronic/online fax server and that clearly indicates that the bid was received before the solicitation closing date and time.

Section 08 titled "Transmission by facsimile or by epost Connect" is deleted in its entirety and replaced with the following:

1. Facsimile

- b. For bids transmitted by facsimile, the CRA will not be responsible for any failure attributable to the transmission or receipt of the faxed bid including, but not limited to, the following:

 - iii. incompatibility between the sending and receiving equipment;
 - iv. delay in transmission or receipt of the bid;
 - v. failure of the Bidder to properly identify the bid;
 - vi. illegibility of the bid; or
 - vii. security of bid data.
- c. A bid transmitted by facsimile constitutes the formal bid of the Bidder and must be submitted in accordance with section 05.
- d. The bid solicitation number should be identified in the cover page of all faxed transmissions.

- e. Bidders must ensure that that they are using the correct facsimile number.
- f. Bidders are discouraged from using colours and shades in their bid documents as transmittal process may render the information non readable.

2. Electronic/Online Fax Service

- a. Unless otherwise specified in the bid solicitation, bids may be submitted by using an electronic/online fax service (for example eFax, Metrofax, Myfax, Hellofax, Ring Central Fax etc.),

Section 21 titled "Code of Conduct for Procurement-bid" is hereby deleted in its entirety.
