- One (1) Adobe® PDF format copy of the completed Appendix B (Respondent Declaration), signed and dated by an authorized representative of the Respondent;
- Documentation supporting the Respondent’s ability, in full compliance with all applicable laws, regulations, and other authorities, to purchase and deliver the required Goods to the Recipient in Mexico; and
- Documentation supporting the Respondent’s ability, in full compliance with all laws, regulations and other authorities, to handle the removal and final disposition of decayed radioactive reference sources from the Recipient’s facilities in Mexico.

- **Copies of the Respondent’s valid certificates, authorizations, permits or licenses required under the regulatory requirements in Mexico** supporting the Respondent’s ability, in full compliance with all laws, regulations and other authorities, to handle the removal and final disposition of decayed radioactive reference sources from the Recipient’s facilities in Mexico.
