BARRICADE WARNING TAPE

1. **Definitions**

- 1.1 This purchase description describes the requirements for "Barricade Warning Tape" for use by Royal Canadian Mounted Police personnel. The specific item covered under this purchase description with MMR# is:
 - i. 110379 – Barricade Warning Tape
- 1.2 This purchase description or other information issued in connection therewith, may only be used for specific enquiries, solicitations, or orders placed on behalf of the Royal Canadian Mounted Police.
- 1.3 This purchase description supersedes all previous purchase descriptions for R.C.M.P. Barricade Warning Tape.
- 1.4 This purchase description has been translated in French from this original English language document.

2. **Applicable Specifications**

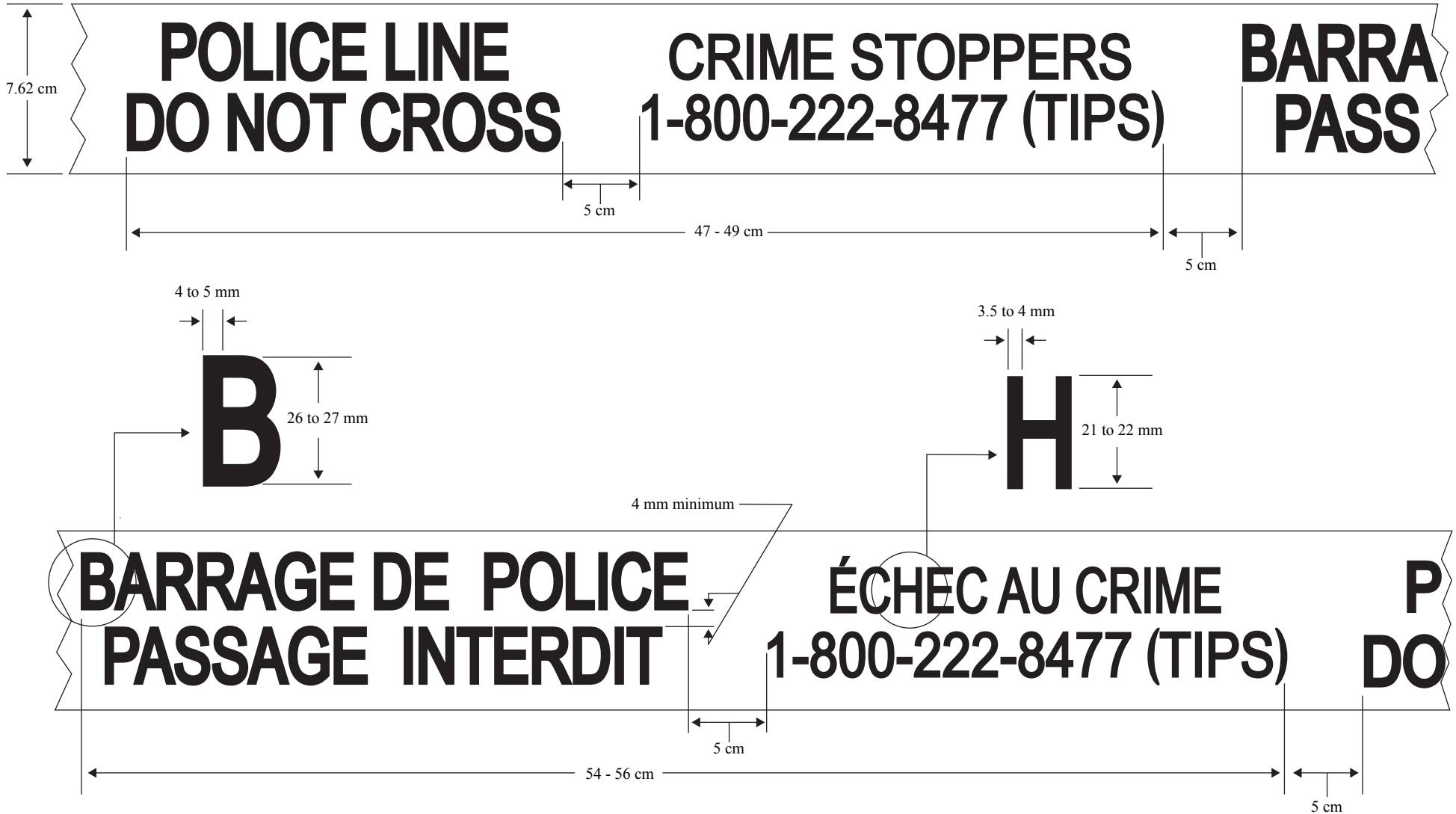
3. **General Requirements**

- 3.1 The article or material covered by this purchase description shall be free from imperfections or blemishes such as may affect its appearance or serviceability.
- 3.2 **Design** – Barricade Warning Tape shall be a 7.62 cm wide polyethylene tape, colour yellow, with a black letter message, for use by R.C.M.P. personnel to mark police incident locations.

4. **Detail Requirements**

- 4.1 **Materials** – Barricade Warning Tape shall be made of heavy duty poly tape 101.6 µm (4 mil) in thickness made from strong abrasion-resistant linear low density polyethylene resins. The colour shall be bright yellow with an ultra-violet inhibitor to make the tape reusable multiple times.
- 4.2 **Width** – Barricade Warning Tape shall be 7.62 cm (3") wide.

- 4.3 **Text** – The tape shall have text printed in black letters in two rows as indicated in Dwg. 1. An acceptable font shall be Arial Bold. All letters shall be in upper case. The lettering ‘POLICE LINE DO NOT CROSS’ and ‘BARRAGE DE POLICE PASSAGE INTERDIT’ shall be 26 mm – 27 mm high. The lettering ‘CRIMESTOPPERS 1-800-222-8477 (TIPS)’ and ‘ÉCHEC AU CRIME 1-800-222-8477 (TIPS)’ shall be 21 mm – 22 mm high. The text shall alternate between the complete English and the complete French message. The text shall be centred between the top and bottom edges of the tape with a minimum gap between the two rows of text of 4 mm. The length of one full example of the English and French text including spaces between text components shall be 111 cm - 116 cm.



Other than the lettering thickness and the tape width, all measurements are subject to a 5 mm tolerance.
Tape width tolerance is +2 mm.
