## Amendment 010

This amendment is raised to:

1. Answer questions that were received from Industry; and
  2. Modify Schedule B – Schedule of Deliveries

### 1. QUESTIONS AND ANSWERS

**QUESTION 1:** Nowhere in the quote do I see that the exchange rate protection clause would apply to this contract. In the event that it was not provided, is it possible to add it, given the possible variation in rates, and the period over which the contract is concluded?

**ANSWER 1:** Exchange rate fluctuation risk mitigation is not offered for this requirement.

At Article 3.1.5 Section II: Financial Bid

**INSERT: 3.1.5.4 Exchange Rate Fluctuation**

The requirement does not offer exchange rate fluctuation risk mitigation. Requests for exchange rate fluctuation risk mitigation will not be considered. All bids including such provision will render the bid non-responsive.

**QUESTION 2:** For optional goods and services for the eastern regions (items 1.2 and 3.2 in Schedule A), is it possible to specify a destination to consider for submission as there is a big variation between Ontario and Newfoundland?

**ANSWER 2:** Schedule B is being amended to include the delivery locations for optional units.

**QUESTION 3:** DID-SE-02 of the Test and Certification Plan on page 11 of the Statement of Work requires that test must be conducted on the first unit for push and side-tow tests by vessel of similar size, validating TSOR 4.5.1.1 through 4.5.1.7.

TSOR 4.5.1.1 through 4.5.1.7 does not specify vessel size, power or towing capacity. DID-SE-02 also demands that the test on the first unit be conducted following ASTM F1599-95(2018) Section 6 and Section 7.

ASTM F1599-95(2018) Section 7,

- 7.2.1 notes: "The test will be considered concluded when the predesignated vessel is able to tow the device away from the dock in a safe and proper configuration".

- 7.2.2 notes: "The test will be considered concluded when the response vessel has completed all towing tests and recovered and stowed the device in a safe and proper configuration".

Can Canada clarify if the contractor is responsible for supplying such vessel for these tests? If so, can Canada clarify the requirements for the predesignated vessel?

**ANSWER 3:** The contractor is responsible for preparing and performing all testing required in the Contract. This includes supplying one or more vessels (as needed) for any on water testing required. It is up to the Contractor to determine which vessel(s) are suitable to tow the barges and suitable to use during testing.

**QUESTION 4:** Would Canada accept the use of Gamma rays in replacement of the radiographic testing of the welds instead of x-rays as specified in the TSOR Appendix A, the radiographic results being very close?

**ANSWER 4:** As specified in the TSoR only radiographic testing of the welds using x-rays will be acceptable to Canada.

**QUESTION 5:** Will a Certification issued by, and Welding Procedure approved by one of the Transport Canada recognized organizations be acceptable in lieu of certifications required under sections M5(i) and M5(ii)?

**ANSWER 5:** Only the certifications described within the Technical Bid Evaluation (M5(i) and M5(ii)) will be deemed acceptable.
