## **1. Firm Price**

- 1.1. The commercial air transportation services all-inclusive firm price must include all costs incurred to perform the Work of the contract, from the airport of embarkation to the airport of debarkation, i.e. These costs include aircraft handling fees, landing fees, airport fees, security fees, passenger meals, passenger/cargo handling fees, per passenger fees such as airport improvement fees (AIF), airport facility fees (AFC) and costs associated with aircrew requirements (lodging, meals, and transportation).
- 1.2 The all-inclusive firm price excludes GST/HST, all exempt fees as detailed in sub-section 1.3, Canadian customs duties and excise taxes and fuel charges but includes oils and lubricants.
- 1.3 NAV CANADA: Canadian air navigation fees and Canadian Air Travellers Security Charges are not to be included as they are exempted for DND and companies doing work under the authority of DND. DND will not reimburse the carriers for these expenses.
