### **Amendment 004**

This amendment provides responses to bidder questions and modifies Annex B Basis of Payment.

1. Bidder questions and Canada's responses:

Q4: Please advise on the amount of space required around each genset to perform checks.

R4: Canada does not define the space around each of the gensets. It is up to the Bidders to propose how they will meet this requirement.

Q5: The required square feet of storage in the solicitation at Annex B Basis of Payments appears to be incorrect.

A) Please label the depth, width and height dimensions in Appendix 1 to Annex A.

B) Would it be possible to get square feet surface area and the height as a separate number?

R5: A) The dimensions listed in Annex A Appendix 1 are in the order of length x width x height in centimeters.

B) No. Bidders must calculate the measurements at Annex A Appendix 1. The measurement provided in Annex B Basis of Payments will be deleted.

“Extras” will not be allowed. It is the responsibility of the Contractor to take into account traffic, weather and other common mitigating factors.

## B2 MONTHLY STORAGE - CEILING PRICE

Monthly payments are subject to a Ceiling Price for storage of the equipment detailed in the SOW, as such Canada will only pay for the number of months as applicable that the equipment is in storage. Payments will be issued to the Contractor upon the Contractor's completion of Deliverables #3 described above in Table B1 and end at the completion of Deliverables #4 described above in Table B1. In the event of storage for a partial month the Contractor must pro-rate the invoice for payment for the days of actual equipment storage.

The Bidder must complete the following tables for all line items and calculate the yearly Ceiling Price (Columns A and B). The Year 1 Ceiling Price (B) will be calculated by multiplying the Monthly Ceiling Price (A) by twelve (12) for both the Contract Year 1 and for the Option Year and these amounts will be evaluated in the Bid Evaluation process.

Option period if activated, via Contract amendment by the PSPC Contracting Authority will be subject to the same terms and conditions herein.
