Q1 - Are their currently part/full time staff that would fall under the building services act?

A2 – No, there is currently no part/full time staff that fall under the building services act.

Q2 - Approximately how many man-hours are spent on the Common area cleaning services?

A2 - The approximate estimation is 1 (one) person for 40 (forty) hours per week.

Q3 - Would Canada consider the possibility of breaking off the contract in three different RFP for a company to bid only on the grass & ground maintenance? Or would Canada consider the possibility that a company bid only on the grass & ground maintenance portion of this actual RFP?
