Questions and Answers

Q1: Do we submit our own proposal or is there a standard format that your department uses internally?

A1: Please refer to Part 2 – Bidders Instructions and Part 3 – Bid Preparations Instructions of this Request for Proposal listed on the solicitation page of Buy and Sell.

Q2: On page 9, PART 3 - BID PREPARATION INSTRUCTIONS/Section I: Technical Bid/Point B, it states “In order to facilitate the evaluation of the bid, Canada requests that Bidders address and present topics in the order of the evaluation criteria under the same headings.” Can you clarify? Also, if we do not have any corporate experience for a particular stream, do we need to address and present that?

A2: Part 3 – Bid Preparation Instructions provides recommendation on how to prepare your bid for submission. It recommends to respond to the evaluation criteria by using the same headings and order as specified. If you do not meet the corporate experience for a particular stream, you are not required to submit a bid for that stream.

Q3: On page 28, PRICING SCHEDULE/General Instructions it mentions “As a minimum, the Bidder must respond to this pricing schedule by including in its financial bid its’ quoted all-inclusive firm hourly rates in Canadian Dollars, excluding taxes for all Provinces and Territories listed or for all Provinces and Territories where they are able to provide services.” Should the hourly rate include any travel and accommodation costs?

A3: The all-inclusive firm hourly rates must not include travel and accommodation costs since those costs are reimbursed as per Annex B, Basis of Payment, article 2.0 Travel and Living Expenses, point b).
