AMENDMENT 002

Amendment 002 is raised to:

1. Provide answers to questions received with regards to this Request for Proposal (RFP).

Questions and Answers

Q4: We are a new Company but have great access across Canada and amazing experienced Registered Nurses. We ask the Government of Canada to make an exception of requiring 1 or 2 years of being in business. We have been helping Ontario with COVID-19, and we are very organized, efficient and ready to help.

A4: The required experience must have been in the last two years from the date of this solicitation but could have been all achieved in the last year.

Q5: I am writing seeking clarification on the provision of PPEs. Will we be providing our own PPEs for the nurses?

A5: It is identified in Annex A – article 9.1.

Q6: Annex A - 9.2, Contractor's Additional Obligations. It is indicated that unless otherwise specified, the Contractor must use its own equipment for the performance of the Work; when should the Contractor use his own equipment?

A6: The Contractor can provide its resources with its own equipment if it wants to use equipment other than what is listed in the Statement of Work, in particular in Annex A – 4.1.1, 4.2, and 9.1 that PHAC is providing.

Q7: Would it be possible to share, what is understood by PHAC in this statement?

A7: See the answer to Q6.

Q8: Is it possible to share the expected lead-time between a request and the start of the execution of services?

A8: The time periods in the Task Authorization process detailed in Part7 Article 1.2 Task Authorization G and H will be used to detail the time between a request and the start of the execution of the service.

Q9: Can we have an overview of the duration of a Task Authorization (TA) for a nurse? We would like to have an idea of the type of schedule that would be requested.

A9: No, it is not known at this time and will vary from TA to TA.

Q10: **Annex A and B present the terms for the reimbursement of travel expenses. Is it possible to know under what circumstances the travel expenses will be reimbursed because there seems to be incongruences between these 2 annexes, at Annex A, article 9.6 - Travel and Living and Annex B - 2.0 Travel and Living Expenses?**

A10: It is understood that in some circumstances, a Contractor may have to use resources that live in a different location within the region at which the service is required in order to staff the number of required resources. In such circumstances, the Contractor would identify the requirement to the PHAC TA contact and they would either pre-approve the travel or modify the TA.

Q11: **The closing date of June 23 is very short. We request an extension of 2 weeks to the closing date. We need more time to compile the references for the nurses as required in MTC1 and MTC 2 for each Stream.**

A11: The bid closing date has been extended to June 30, 2020 at 14:00 EDT from the previous amendment.

Q12: **Do we have to supply the references for each nurse requested in MTC1 and MTC2 for each stream? That entails collecting 102 references if bidding on all Streams.**

A12: The references in MTC1 and MTC2 are for the Bidder's experience providing a minimum number of nursing services under single contracts in the last two years from the date of this solicitation. It would be expected that the Bidder would only need to provide 5 references for each Stream.
