Q.1	We would propose to build this at our Campbell River Terminal and we could deliver with our Heavy Lift Crane to site.
A.1	<p>Specification states: Deliver the completed ramp F.O.B. a standard flat deck scow or concrete float in the Vancouver area or at a suitable barge loading facility in the Strait of Georgia. The scow or concrete float will be supplied by others. The work shall include loading the ramp complete onto a scow or concrete float. The tender shall clearly identify the intender place of delivery.</p> <p>The project site where ramp will be installed is Port Hardy. The concrete float will be fabricated in Lower Mainland. Ramp may be fabricated and loaded onto concrete float anywhere in water accessible Lower Mainland or in similar fashion in the Strait of Georgia. Campbell River is a suitable location to load ramp onto concrete float.</p>
Q.2	Regarding delivery of the Ramp. On page 1 of the Invitation to Tender sheet it states "FOB Destination" of Port Hardy. In the Technical Support documents section 1.5 it states FOB "on a standard flat deck scow supplied by others in the Strait of Georgia". Could you please clarify ?
A.2	FOB Port Hardy is incorrect. See A1 above for full clarification.
Q.3	Can you advise if our barge loading facility in Saanich Inlet is considered within the Strait of Georgia?
A.3	Yes. Sidney Inlet, East coast Vancouver Island and Greater Victoria waterfront areas can be considered within the Strait of Georgia.
