Amendment 009 is raised to:

- 1) Amend the BoP for Premium Meals and add a description;
- 2) Provide an revised GFE/GFM list which removed all PPE for firefighters and;
- 3) Replace the financial evaluation form with version 5;
- 4) Provide the document NAVAIDS-Telecom Historical Data.xls and;
- 5) Answer the questions.
- 1) At **RFP BoP Table 4 and 4A**, **CHANGE** the Premium Meals from **Percentage** to **Firm Fixed Rate** and at the SOW table **2.3.8 Food Services Requirement**, **ADD** item **2.3.8.1.15 Premium Meals** and the following description and level of effort:
 - "Provide meals for special events. These events may require a special set up as well as meal provisions. These events would include special Christmas dinner, mess dinners for military and special meals for visiting dignitaries and receptions at various locations on base. Generally, orders will be placed with a minimum of 7 days advance notice, however, last minute requirements may arise. The Customer will be invoiced for the variable cost of meals that are cancelled with less than 24 hours' notice. 3 Special Events per year with 120 people. 2 outside normal working hours and 1 within. 8 Special Events per year with 25 people. 4 outside normal working hours and 4 within. Meals are prepared, delivered and set up on time as negotiated with the DO and in compliance with client selected menu.
- 2) See attached the **revised GFE/GFM** list which has the "PPE for firefighting" removed.
- 3) **DELETE** Goose Bay Annex I Financial Evaluation REV 4 and **REPLACE** with **Goose Bay Annex I** Financial Evaluation REV 5
- 4) See attached NAVAIDS-Telecom Historical Data.xls.
- 5) Answer questions below:

Question 259

Canada is requested to advise which line(s) / table(s) of the Annex I Financial Evaluation Form bidders should use to capture their labour costs associated with the proposed staffing plan?

Answer 259

The labour should be included in your "firm fixed, all-inclusive annual price" for the Management and Administration Services (item 1.1.8) in Table 2 of the financial evaluation sheet.

Ouestion 290

Annex K- Loan and License Agreement states under Instructions to Contractor at No. 2 "The list in Schedule "B" includes all equipment Loaned to the Contractor for which it has Care, Control and Custody". The Agreement further provides that the Terms and Conditions are set out in Schedule "A". Schedules "A" and "B" were not included with the Agreement or otherwise described in the RFP.

Will Canada provide Schedule "A"- Terms and Conditions and Schedule "B"- List of Equipment?

Answer 290

To be answered on an upcoming amendment.

Revised Answer 292 (Clarification from Amd. 008)

The items in question were transferred to the current contractor, 17 years ago, through authorized Disposal Action as, at that time, there was no determined need for their continued use, as property of Canada, and the items were declared surplus. As the incumbent legally owns these items, any requests for acquiring these items must be sent directly to them. It must be noted, that the majority of the items in question are now 25+ years old. Canada has no plans to acquire back any of these previously disposed items.

Question 297

In reference to SOW 1.1.8.1.7 – Can Canada please provide a typical list of DND courses and conferences mandated and provided by DND, with location of courses, so that bidders can estimate the cost of courses and travel?.

Answer 297

The list of courses is not constant, and is based on requirements. If fixed price staff are attending training, their labour is already included in Fixed Price; however, like DND staff attending training, if they have to attend class or travel outside of working hours, and they are entitled to overtime for this through their collective agreement, then DND would reimburse the contractor for those costs.

Question 299

In reference to SOW 4.3.3.10 and Table 4.3 – Service Levels, asks contractors to "Operate the Water Treatment Plant". Can Canada please confirm that all labour and materials, including water treatment chemicals, to operate the water treatment plant should be included in the bidders fixed price?

Answer 299

Question 309

RFP Amendment 006 – Answer 224, in part, says "If any issues have arisen during the controlled cable operations or training, the firefighters will inform the tower that the AAS serviceability is no longer valid and the qualified AAS tech must be called in to inspect the system.". Since there is no requirement for AAS maintenance in the SOW, can Canada please clarify that the qualified AAS tech being referred to here is a military AAS technician?

Answer 309

AAS maintenance to be added to the SOW in an upcoming amendment.

In relation to Annex B -Basis of Payment Page 49 and Financial Evaluation v2. Table 2 & Table 4: Labour will be paid under SOW item 2.3 in Table 2 and all food items will be paid in Table 4. Please clarify how other costs such as kitchen equipment repair, vehicles for food services, etc. will be paid.

Answer 333

Ouestion 340

Financial Evaluation Table has section Premium Meals for Catering within Normal Hours of Operations, however, this section is not in the RFP?

Answer 340

The Premium Meals is referenced in the BoP of the RFP and is to be changed to match the financial annex to Firm Unit Rates. Also this item description has been added to the SOW at table 2.3.8 Food Services **Requirement** as item **2.3.8.1.15** in this amendment 009.

Provide meals for special events. These events may require a special set up as well as meal provisions. These events would include special Christmas dinner, mess dinners for military and special meals for visiting dignitaries and receptions at various locations on base. Generally, orders will be placed with a minimum of 7 days advance notice, however, last minute requirements may arise. The Customer will be invoiced for the variable cost of meals that are cancelled with less than 24 hours' notice. 3 Special Events per year with 120 people. 2 outside normal working hours and 1 within. 8 Special Events per year with 25 people. 4 outside normal working hours and 4 within. Meals are prepared, delivered and set up on time as negotiated with the DO and in compliance with client selected menu.

In relation to SOW 4.3.3.9; Operate and Maintain Sanitary Collection Systems, can Canada please provide the size of 5 septic tanks that are required to be pumped annually?

Is it Canada's intention that all GFE and GFM will be replaced by Canada under normal wear and tear usage by the contractor?

Ouestion 347

Relating to Amendment 6, Q&A 229, Canada has declared that runway chemicals are paid for by Canada as a cost reimbursable expense. Under RFP Annex 3 Basis of Payment and Financial Evaluation, no flow through costs for materials are mentioned with the exception of Task Authorizations. Can Canada please explain why this is cost-reimbursable?

Ouestion 354

- a) Firefighting PPE are listed in GFM, if at Take-over the contract deem that the PPE does not meet the appropriate NFPA standard will Canada replace them?
- b) If the contractor require more firefighting PPE, will the Canada purchase them and add it to the GFM List.
- c) Please confirm what is meant in SOW 3.5.12.2.1 CFM the contractor "Provide ... personal protective equipment." when they are already provide as GFM?

Answer 354

The contractor is responsible for providing IPE/PPE for firefighters and for the replacement of IPE/PPE throughout the life of the contract. The GFE/GFM list, with all of the firefighter IPE/PPE and associated SCBA test equipment removed, has been revised and provided in this amendment.

Question 355

Please confirm that the labour is to be included in Table 2 of the Financial Evaluation Rev 3 and the Food will be in Table 4. What is meant in the Performance Standard is only the time to be negotiated with the DO. This is not a Task Authorization.

Answer 355

Confirmed. Second question was missed. To be answered in an upcoming amendment.

Ouestion 357

Please confirm that during the contract, GFM (i.e. pillows, towel face, sheets, blankets, etc.) that need to be replaced due to wear and tear will be cost reimbursable?

Answer 357

To be answered on an upcoming amendment.

Ouestion 358

Bidders understand that the term of the leases will only be for annual term and the lease price is also for an annual amount. There are 3 scenarios that a bidder can take for pricing buildings for their own use (not mandatory).

Scenario 1. For Phase-In - Takeover, bidders do not include any lease costs but only the annual lease in Year 1.

Scenario 2. Pro-rate lease cost base on the take-over schedule and balance of the lease cost for Year 1. This will distort the Summary as only part of the lease will be in year 1 which is then multiplied by 20.

Scenario 3. Bidder do not include any lease cost for Take Over but only in Year 1.

Can Canada confirm which scenario should the bidder price for evaluation purposes?

Ouestion 367

Per RFP Annex B 6.4, the contractor will be reimbursed for travel and tuition costs for DND mandated courses. Can Canada please provide a list of DND mandated courses? Can Canada confirm that contractor's labour to attend will be paid and included in the TA?

Answer 367

The list of courses is not constant, and is based on requirements. If fixed price staff are attending training, their labour is already included in Fixed Price; however, like DND staff attending training, if they have to attend class or travel outside of working hours, and they are entitled to overtime for this through their collective agreement, then DND would reimburse the contractor for those costs.

Question 371

For phase-in, please provide the specific caretaker and fire warden requirements and what are the position qualifications to perform the work?

Answer 371

Fire Warden's duties and responsibilities are defined in Wing Fire Orders. This is defined in FMD 1013, as well as SOW Item No. 3.5.8.5.5 and 3.5.8.7.7. Caretaker Performance Standard is provided in SOW Item No. 1.2.12.3.1.

Question 373

Section 4.3.11.4.1 in Annex A-4 mentions "Conduct annual structural inspections of RTA Rappel towers". Can Canada confirm if there is more than 1 Rappel Tower?

Answer 373

There is only one Rappel Tower.

Question 376

It is requested Canada provide estimated quantities of activities for Grounds and Landscaping, Range Training and Security and Access Control Systems.

Answer 376


For grounds and landscaping refer to SOW 4.3.10 Annex A and Annex G. Range and training area is fully defined in the SOW 4.3.11. Access Control is TBD.

Question 388

Will Canada please clarify the expectation of how building lease expenses are to be included in the pricing tables? We understand from Answer 140 of Amendment 5 that the contractor will sign a \$0 lease with Canada for the mandatory buildings. We also understand from Answer 147 of Amendment 6 that lease values of the buildings the contractor must occupy ("yellow' cells), are not to be included in the pricing. Will Canada confirm that the lease values of any other buildings the contractor may choose to occupy are to be included in the pricing for the services, or state otherwise if this is not the case? For example if we chose to occupy space within building 271 SSS HQ to enable effective and efficient management communication would we need to include the cost of \$485,469.90 per annum in our submitted price?

Answer 388

A new table (9) in the Financial Evaluation form has been added to allow the Optional Lease Rates to be entered in order to determine the contract value but these rates will not be evaluated in the Bid Financial Evaluations.



Ouestion 389

SOW 2.4.8.1.4 states that the contractor has to allow at least one major credit card for payment methodology for accommodations. Can Canada please clarify that the merchant fees associated with use of the credit cards by DND's customers are directly billable to DND?

Answer 389

DND will not reimburse the contractor for credit card fees.

Ouestion 392

The SOW has the requirement for Implement and Perform Corrective Maintenance (CM) program for CFR vehicles. Perform Corrective Maintenance (CM) to Commercial and SMP vehicles in accordance IAW the applicable CFTOs or OEM manuals.

Can Canada provide a list of SMP vehicles as these do not appear to be listed in Tables 2.2-2 and 2.2-3? Answer 392

Both Tables 2.2-2 and 2.2-3, from current RFP, are complete and accurate and there are no Standard Military Pattern (SMP) vehicles missing.

Question 393

In the SNIC plan and in the Reference B-GG-238-000/AG-002 Snow and Ice Control – Vol 2 – Airfield Snow and Ice Control (M) – it discusses runway de-icing and friction testing. Please advise as to which line item in the SOW this activity should be applied.

The line item referring to airfield SNIC is Line Item 3.3.8.1.3

Question 399

In reference document B-GA-164-000/AA-001_ACMO, 110 - Administration, 110.06 - Crew Composition, it states that "at the discretion of the CO/OC, individuals may be assigned to more than one crew position simultaneously. Minimum manning requirements should be determined by the CO/OC and published in applicable unit orders." In the section 3.2.9.1 of the SOW the requirement states "the ATC Section must be staffed with a minimum of one controller, located in the tower, capable of providing continuous VFR control." The performance standard states "no instance of ATC Section left unattended during flying activities within the specified watch keeping hours."

Are single controller mid-shifts authorized?

What is the minimum staffing that has been determined by the CO/OC and published for each ATC facility?

As per the SOW and the ATC section orders, during minimum manning, the ATC section must have at least one controller in the tower that is capable of providing continuous VFR control 24/7. During this time, this controller may fulfill the duties of the ground controller and tower data assistance.

Question 400

In Annex I Financial Evaluation REV 3 Price Summary tab, cell B-13 (price for food services) is linked to Table 4 Food Services tab, cell D-36. However, in Table 2 Operations and Maint. tab, cell C-9 is blank where the sheet appears to be asking contractors to present their Firm Fixed Contract Year 1 price. Should

this cell not be left blank by contractors to prevent counting this price twice on the Price Summary tab? Or is there another explanation for this cell?

Answer 400

To be answered on an upcoming amendment.

Question 401

The 5 Wing Billeting report shows historic room occupancy that seems to correspond with the estimated quantity of 50,000 meals required for item 2.3.8.1.1, however, is also approximately 3 times greater than the estimated quantity of 5,395 rooms assigned per year for item 2.4.8.1.4. Is this because the average stay in these rooms is only 3 nights? Will Canada provide clarification on what the estimated number of occupancy nights is?

Answer 401

The estimated qty of 50,000 meals provided equals three meals per day at an average of three days per stay for the estimated quantity of 5,395 rooms assigned per year. So three nights per stay is accurate.

Ouestion 402

In Answer 76 of Amendment 5, Canada states that there are currently 30 RHUs available to the current contractor. Will Canada please provide the cost associated with occupying these RHUs (assuming they are still available)?

Answer 402

RHUs are not part of this tender and no costs are to be included in the bid financials.

Question 403

Will Canada provide historic reliability data on airfield communications, RADAR and NAVAIDS and TIS equipment?

Answer 403

Historical airfield communications, RADAR and NAVAIDS data (NAVAIDS-Telecom Historical Data.xlsx) has been provided with this amendment.

Ouestion 404

Building 1068 in the GFA table is described as PCB Storage. Will Canada define what PCB means in this context?

Answer 404

Polychlorinated Biphenyl and any material containing or contaminated with Polychlorinated Biphenyl.

Question 405

It is requested that Canada provide an estimated quantity for signage services as indicated in SOW 4.3.13.1.

Answer 405

There is no estimated quantity as this element will vary as HR (mil and civ) are posted, change positions or retire.

Question 406

It is requested that Canada provide the number of raw wells as indicated in SOW 4.3.7.34 to 4.3.7.36.

Answer 406

There are currently no water trucks or water trailers in use. There is one well located in the PTA at the Austere Operations Training Centre.

Question 407

Relating to SOW 4.2.3 - 4.2.14; SOW 4.2.17 - 4.2.18 and SOW 4.2.5.3.2, it is requested that Canada confirm if all estimated quantities for Tables 4.1 & 4.2 are included in the SOW? Estimated quantities for many costplus items seem to be missing.

Answer 407

Yes, quantities are missing as they cannot be defined. For the cost plus elements Canada is leaving it up to the bidders to determine the level of effort they will apply. It is anticipated that these elements will vary in the first few years but stabilise as Canada agrees with the contractor's performance.

Question 408

Relating to SOW 4.3.6.5, Service Standard 1, it is requested that Canada provide the estimated quantity of pressure vessel tests to be performed annually.

Answer 408

To be answered on an upcoming amendment.

Question 409

Relating to SOW 4.3.6.9, it is requested that Canada verify what buildings are part of PTA per the Facilities Catalogue.

Answer 409

There is a separate spread sheet with the building information

Question 410

Relating to SOW 4.3.7.33, it is requested that Canada provide the number of distribution points for raw water testing.

Answer 410

The number of sampling points for water quality monitoring within a distribution system is determined by the contractor taking into consideration the history of bacteriological and operational monitoring of the system, in conjunction with:

- a. regular physical inspections, and
- b. a current source water assessment report, if available.

This will determine the problem areas and identify the sampling points (number and location). As part of our QM program, Canada recommends to include the following sampling points in their water monitoring: Health center(s), kitchens (Messes)/CANEX, gyms, Headquarters, daycare/school(s), as well as one random point that is different every week.

Regarding testing for E. Coli and total coliform: For a facility such as the 5 Wing Goose Bay system that serves appx 9000 people, Health Canada recommends 1 sample per 1000 people (per month) for E. Coli and total coliform testing. In municipal-scale distribution and storage systems, the number of samples collected for total coliform testing should reflect the size of the population being served, with a minimum of four (4) samples per month (i.e. weekly; the water samples should be taken at regular intervals throughout the month). E. Coli and total coliforms should be monitored at least weekly in water leaving a treatment plant. As well, during high risk events (e.g., flooding, extreme or unusual weather events), there may be a need for additional monitoring. Additional monitoring should also be done when alterations are made to treatment,

plumbing, or distribution systems (i.e. routine distribution system operation/maintenance (e.g., pump start/stops, valve opening and closing) or unplanned events such as power outages or water main breaks (Health Canada, 2012a; Health Canada 2020).

Ouestion 411

It is requested that Canada clarify what the Canadian Forces Fire Marshall's office standards are for the life expectance of an ARFF vehicle.

Answer 411

The ARFF DND "Fire Truck" CFR 10210 is a 1 Cdn Air Div deployable asset and is no longer available to the contractor. It's being taken out of service.

Ouestion 412

In relation to Financial Evaluation Spreadsheet, Table 8, it is requested that Canada confirm if estimated spend in cost plus items 4.2.3 - 4.2.14 are correct. Given that these items are mainly labour the estimated spend of \$3.2 million seems high.

Answer 412

Yes, estimated spend in cost plus items 4.2.3 - 4.2.14 are correct.

Question 413

Reference: SOW 4.3.8.2.2, Hazardous Materials. Since analysis types can vary in price, it is requested that Canada provide a list of potential analysis needed to identify the estimated quantity of 86 samples.

Answer 413

HazMat Waste List has been provided to all participating vendors and has been added on BuyandSell.gc.ca in this amendment 009.

Question 414

Reference: Financial Evaluation Spreadsheet, Table 8, RPOps. Some costs can be considered to be Cost reimbursable or firm fixed costs or vice versa, without clear declination, it is recommended that all cost items be firm fixed price so that it is fair to all bidders and makes fair evaluation. It is requested that Canada confirm how it will want the contractor support its invoice for cost reimbursable.

Answer 414


All items in table 8 are either "firm fixed" or "cost plus fee.". Invoicing shall be as per clause 7.9 Invoicing Instructions. The financial evaluation will remain unchanged.

Ouestion 415

Reference: SOW 4.3.7.41. It is requested that Canada provide more details relating to the scope of the environmental audit? It is also requested that Canada provide an example of the Wing Environmental compliance audit to be completed by a third party.

Answer 415

The contractor will be required to complete environmental audits on an as required basis when an environmental issues arises. These could be but not limited to, hydrocarbon spills, discovery of asbestos or storage tanks systems. Past examples are specific to an environmental issue and Canada cannot provide due to confidentiality.



Ouestion 416

SOW 3.5.3.7 defines Medical Emergency Response as "Medical Emergency Response by Fire Protection Services in fire or rescue vehicles as required by the Wing." It is requested that Canada clarify the rescue (other than ARFF) capabilities required.

Answer 416

This requirement is defined in the applicable references included in the Emergency Services section of the SOW/RFP.

Question 417

Reference: Service Standard 8, pg. 384. For testing life safety anchor systems, it is requested that Canada clarify what is involved in the certification of life safety anchors? Also, please clarify the number of anchor points to be tested.

Answer 417

IAW Canada Occupational Health and Safety Regulations (SOR/86-304)

- (8) The employer must ensure that a person who works on an aerial device, boom-type elevating platform, scissor lift platform, forklift truck platform or any similar personnel lifting equipment in the circumstances described in subsection 12.07(1) uses a fall-restraint system that is connected to
- (a) an anchorage that is specified in the instructions of the manufacturer of the lifting equipment; or
- (b) if no anchorage is specified by the manufacturer, an anchorage that is certified by a person who is authorized to exercise the profession of engineering in Canada and that meets the requirements set out in CSA Group Standard Z259.16.

The determination of the number of anchor points to be tested is the responsibility of the contractor.

Question 418

It is requested that Canada provide the contract values for the incumbent for the years, 2016, 2017, 2018, and 2019.

Answer 418

As at 23 Sep 2016, the Bridge Contract award value was \$114,999,634.69. The contract has been subsequently amended to a current value of \$187,900,135.72.

Ouestion 419

Assuming that the contractor is responsible for ordering and managing the cell phones for use by DND on the base, will the contractor have the ability to order cell phones for its use in Goose Bay at the same government rate?

Answer 419

Yes, the winning contractor may have access to the same government standing offer rates. The contractor will need to sign an agreement with DND to follow the same restrictions for use and will be limited to the employees working on the base at 5 Wing.

Ouestion 420

Re: Table 3.3-2

1.9 – Baggage Tug & Carts with and Without Operator

1.13 - Tow Tractor without Operator

1.25 Forklift, with and without operator

Who will be operating these when there is no operator provided as this could pose a reliability risk to the contractor?

Answer 420

Without Operator: the Operator will be a DND employee, a contractor approved by DND, or in some cases, aircrew from various Nations. Anyone operating the equipment must be qualified to operate it.

Question 421

Re: Table 3.3-2

B-4 Stands – Can Canada provide the information for the requirement for the B4-Stands? Example: Providing and putting in place, etc.

Answer 421

The requirement for B4 stands is designed for Aircraft Maintenance. CAF and foreign military aviation technician use the B-4 stands in order to efficiently service any aircraft, while providing critical fall protection to ensure a safe work environment.

Ouestion 422

Re: Table 3.3-2

Coordination into-plane servicing of oil, ADI, etc. Can Canada please confirm the intent of this line item? Is this strictly the coordination of activities?

Answer 422

Affirmative – This is strictly a coordination task.

Ouestion 423

With regard to the Real Property Quality Control and Assurance Manager role identified in Annex J 2.3c, and dependent on Canada's answer to Question 148 (Amendment #006), will Canada consider asking bidders to provide a qualifications profile in Annex J 1b – Key Personnel, given the emphasis on scoring placed on 2.3c Real Property Quality Control and Assurance Manager?

Answer 423

Question 424

In Goose Bay Annex | Financial Evaluation REV 3 Table 8 RPOps there are notes provided stating that multipliers of \$45 million and \$15 million are "provided for financial evaluation purposes only based on an estimated level of effort of \$3 million." For avoidance of doubt, will Canada please define what "level of effort" refers to in this context?

Answer 424

The level of effort is based on historical spend. The 45 million is not a dollar figure but rather a multiplier to ensure bidders give best value to Canada in their fee percentage. As an example a too high of a fee, their financial evaluation will be higher (akin to a penalty) for not respecting value to Canada. Consequently if a bidder chooses no percentage fee the financial evaluation will be too low (again akin to a penalty) and not respecting value to Canada. Canada is seeking bidders place a fair fee percentage that represent best value to Canada.

Question 425

In the Take Over Schedule Table 1.2-1 it is noted that Management and Administration is not taken over by the incoming contractor September 23, 2021, nearly 6 months after the phased take-over of services begins

on April 1, 2021. Considering there will necessarily be management and administration activities required throughout the 6 month take over, will Canada confirm how those management and administration costs are to be shown in the bidder's financial submission? Are they to be included in the monthly phase-in, phase-out monthly pricing?

Answer 425

Yes, the management and administration activities required throughout the 6 month take over are to be included in the monthly phase-in, phase-out monthly pricing.

Question 426

In Goose Bay Annex | Financial Evaluation REV 3 Table 5 Task Authorization Rate bidders are required to provide hourly rates for various labour types. For avoidance of doubt, will Canada please define what is to be included in these hourly rates? Are they only supposted to represent the base hourly rate of the contractor's cost to employ each labour type, or is supposed to include costs such as travel, truck charges, access to site, etc.?

Answer 426

The hourly rates are to be for the labour only

Ouestion 427

In Goose Bay Annex | Financial Evaluation REV 3 Table 3 Transient Servicing, bidders are asked to provide a unit rate for "into-plane servicing of oil, ADI, oxygen, nitrogen, LOS and other liquid/gas (per occurrence). Is this unit rate supposed to represent the cost of qualified labour, or the cost of the product/material, or both?

Answer 427

This rate should include the cost of labour only.

Question 428

Regarding SNIC services, there are no response times indicated in the SNIC Map (M). Please confirm what standard you require bidders to meet. Please also confirm that your response to Question 10 in "rfp_w6369-170006_b_amd_003" that SNIC services are required 24/7 in accordance with the SNIC map also includes airfield and domestic services prior to the first scheduled commercial and/or military flight in the morning through to the last scheduled commercial and/or military flight for the day, including for medivacs and/or unplanned flights at any time during the day or night?"

Answer 428

Response time is IAW the priorities identified in the SNIC Plan which is reviewed yearly. SNIC services are required 24/7 which includes airfields and domestic services in order of priority IAW the SNIC map.

Question 429

Given SNIC services is the highest cost driver for this contract including CAPEX for SNIC equipment, associated maintenance/parts, chemicals and labour, can the government clarify response times for the 24/7 SNIC services requirement.

Answer 429

Response times are contingent on the identified priorities set up by DND. They are reviewed, established, and confirmed yearly for the 24/7 SNIC services.

Ouestion 430

It is requested that Canada please provide an estimated quantity of activities as it relates to operating the central heating plant? It is difficult for bidders to estimate the labour resourcing needed without expectations of tasks to be completed.

Answer 430

The existing boiler information:

Boiler #8: 22,727 Kg/Hr, 50,000 Lb/Hr, 12.9 MW @ 690 KPag Boiler #9: 22,727 Kg/Hr, 50,000 Lb/Hr, 12.9 MW @ 690 KPag Boiler #10: 18,181 Kg/Hr, 40,000 Lb/Hr, 10.3 MW @ 690 KPag

The recorded maximum steam flow to the base for past two years is 29,545 Kg/Hr or 65,000 Lbs/Hr of saturated steam at 690 KPag.

The two new electric Jet boilers are rated 21,500 max KW, and designed for 175 psi, and be operated at 130 psig nominal steam pressure

Question 431

Can Canada please clarify what is meant by "shop" supplies from Qs and As #380. Do shop supplies only include small consumables such as rags and cleaners, and will vehicle specific parts be paid for by DND?

Answer 431

Yes, shop supplies are small consumables, such as rags and hand cleaner.


With respect to vehicle spare parts, the majority of vehicles are provided by the Contractor and spares are/should be included with bids. As for CFR plated vehicles, all spare parts, when needed, will be acquired from the Defence Supply Chain. Table 6 in the BOP is Vehicle Maintenance Fees and Vehicle Maintenance which will be entered at Contract Award.

Ouestion 432

In the final RFP SOW 2.6.6 it states that the normal working hours are 0800-1600 hours. Further, it was instructed that the mandatory reference at 2.6.4.5 'SNIC Map' be replaced by the 5 Wing SNIC Plan, which is now a mandatory document.

As part of that plan, timeline information is provided at the following paragraphs (underline and bold added to draw out the details):

- Snow and Ice Control Aim 3.0 "An operational state demands the active runway, adjacent taxiways; aprons and parking areas are maintained as close as possible to blacktop condition <u>24 hours a day</u>, and the MSA and Domestic area to be in a fully functional state"
- SNIC Committee Permanent Members and Respective Responsibilities Heavy Equipment LEAD Operator Responsibilities 3.6.r. "During adverse weather conditions, provide the tower with RSC reports every 4 hours or as requested by the DAC. Scheduled Times are: 1100 hrs; 1500 hrs; 1900 hrs; 2300 hrs; 0300 hrs and 0700 hrs"
- Airfield Operations Aim 2.0 "An operational state demands the active runway, adjacent taxiway's, aprons and parking areas are maintained as close as possible to blacktop condition **24 hours a day**"



- Airfield Operations SNIC Aerodrome Snow Removal Procedures Priority 1 a. "As soon as it starts to snow SNIC equipment is dispatched to commence work on the active runway. These units will remain on the main runway until a 45 Meter wide path has been cleared"
- MSA/Domestic Operation MSA/Domestic Priorities Priority 1 3.0 "Snow and ice accumulation shall be removed on all Priority One areas as shown on the SNIC Map. Priority One roads shall be kept open at all times and cleared to a width of 5.0 metres. Once the snow has stopped falling, these areas shall be cleared to shoulder width"
- MSA/Domestic Operation MSA/Domestic Priorities Snow Removal 5.0 "Snow removal by trucking will be primarily a 2300-0700 hours operation, where roads and parking lots will be widened to improve the overall safety for drivers. All snow will be brought to 5 Wing Goose Bay's snow dump"
- MSA/Domestic Operation MSA/Domestic Priorities Removal of POMVs During SNIC Operations - 8.0 "Parking lot snow removal will be a **2300-0700 hrs operation**"

Given that these timelines are in a mandatory document and many parts of the base are operational 24/7, and given that the working hours from the SOW are 0800-1600 hours, can Canada please clarify the following:

- 1. Is the intention that the contractor provide SNIC services solely 0800-1600, other than as outlined above and in the SNIC plan?
- 2. Is the 0800-1600 hours solely intended to apply to buildings and places of work (as noted in question 10), with all other aspects of SNIC being delivered 24/7 (including airfield, roads etc)?
- 3. Or is the intention different to points 1 or 2 above?
- 4. Can Canada please clarify the Working Days that are expected for this section. Can Contractors assume it is Monday to Friday 0800-1600
- 5. SOW 2.6.6.2 states that there is Point of Contact required for outside of normal working hours to organize a response to an emergency or trouble call. Can Canada please provide a definition and/or examples of emergencies and troubles calls as it pertains to this section?

Answer 432

- 1. Under snowfall conditions, the contractor will need to provide SNIC services outside normal administrative working hours in order to meet the SNIC Plan operational requirements.
- 2. All aspects of SNIC operations are expected to be delivered 24/7 during heavy snowfall conditions and when normal working hours are not sufficient to address the SNIC Plan requirements. The 0800-1600 hours is annotated in order to identify the administrative working hours of CFB Goose Bay.
- 3. Not different; see answer 2 above.
- 4. The contractor is expected to be responsive and to provide SNIC services outside normal working hours, i.e. 24/7, in order to meet the SNIC Plan requirements.
- 5. Trouble calls vary and could include DND simply requesting a change in priorities in order to gain access to a specific location to conduct operations. Emergency is any occasion or instance that warrants action to save lives and to protect property and public health.

Question 433

In the interest of fairness, is Canada responsible for making bidders aware that a new CBA between the incumbent and PSAC has been ratified by PSAC membership to ensure all bidders are aware of pay rate increases and other updates to the agreement?

We understand from the answer to question 355 in Amendment 8 that Canada has confirmed the price of labour for food services is to be entered in Table 2 of the Financial Evaluation as firm, fixed annual price. We also understand from the answer to question 355 in Amendment 8 that Canada has confirmed the price of food for food services is to be entered in Table 4 as a frim unit rate. However, it is not clear why labour and food pricing are separated, creating a situation in which food volume is treated as a variable quantity and the labour to prepare and serve that food is not. How will the contractor be reimbursed for the labour that necessarily accompanies the food for premium meal rates for catering outside normal hours of operation?

If a contractor elects not to occupy an optional building, is it possible to relocate tools and equipment from the unoccupied building to a building the contractor is occupying?

In reference to, Annex A, Statement of Work, A.1.1.10 Structure of the SOW; Annex A1, 2.4.10 Provide Regular Cleaning: At SOW A.1.1.10 under the heading Item Number - Task Authorization (TA) Requirements it States: "Paragraph 10 identifies requirements that cannot be included in the firm price of the contract since the exact scope of the tasks cannot be defined, or the frequency of the activity cannot be determined, or both. They are not predictable at time of issuance of the SOW and may not be recurring requirements."

At Annex A2.4 Accommodations and Janitorial Services, Additional Services, or TA Requirements are expressed under Item 2.4.14. Please confirm that Items 2.4.10 Regular Cleaning, 2.4.11 Miscellaneous Cleaning, and 2.4.12 In-Depth Cleaning are items to be included in the firm price of the contract and not to be performed as TA requirements.

Answer 436

It is confirmed that Items 2.4.10 Regular Cleaning, 2.4.11 Miscellaneous Cleaning, and 2.4.12 In-Depth Cleaning are items to be included in the firm price of the contract and not to be performed as TA or additional services requirements.

Ouestion 437

The file provided does not give the contractor any indication of the estimated quantity per material type, location and pick-up frequency. It is requested that Canada provide this information.

SOW1.1.1.2.2 Transition phase starts after contract award and ends at the start of the Handover. Phase.1.1.1.2.3 Handover phase starts at the end of the transition phase and ends at the start of the O&M. 1.2.3.1 Contract Handover Date: This is the date when the Contractor assumes full responsibility for the Work detailed in the under the SOW. This date is the end of the Phase In.

In light of the above, Q&A 395 states "The Take-Over Timetable in Table 1.2-1 is the schedule to be utilitized for the Handover Phase". The reply is contradicting as Table 1.3-1 is the Handover table. And in Q&A 345, the answer was that both transition costs and take-over is to be included.

Since SOW 1.2.1.1 has 2 parts, Table 1 should have another line item for Take-over. The only description is

"Transition Phase-In - Transition Phase-Out" (which is confusing in itself). It is requested that Canada add another line item for Take Over in Q&A 345 and Q&A 395.b
