- Q1) Appendix B Statement of Work, Section 4: Scope Page 48 Does ESDC have workflow documentation for each file type, and if so can that be shared.
- **R1**) Only information located in the RFP can be provided.
- **Q2**) Appendix B Statement of Work, Section 4: Scope Page 48 Is there any interest in proposals that would include OCR, Automation or BOTS as part f the solution proposal or must bids be based on a lift and shift of current workflows as is, with manual data entry
- **R2**) As part of this Request for proposal, ESDC is seeking bids based on current workflows. However, should bidder include OCR, automation or BOTS in their processes ESDC will consider them as part of the overall proposal.
- Q3) Appendix B Statement of Work, Section 4: Scope Page 48 Does ESDC have interest in imaging services, to reduce the shipping costs of Paper volumes, and to develop and indexed and searchable electronic document set vs paper. If yes should this be proposed as part of our core bid or be provided separately for consideration.
- **R3**) As part of this Request for proposal, ESDC is not seeking information on imaging services.
- Q4) Appendix B Statement of Work, Section 4: Scope Page 48 Does the physical production area have to be segregated from other production areas. If yes does the segregation have to include certain minimum standards for the physical construction of the segregated area (ie floor to ceiling walls, reinforced door frames, badge access entry, security cameras etc.).

- **Q5**) Section 10: Shipping and Turn-Around Time Page 54 ROE Forms Do you have a preferred courier service that you currently use or have used in the past that you are willing to share contact details with the contractor?
- **R5**) No preferred courrier. The winning supplier must secure services of legally constituted service that is insured and bonded.





Q6) Section 11: Deliverables – Page 55 - Is there any latency in Data Gateway that would restrict the speed in which operators data enter?

After a document has been entered into the Data Gateway, is there any opportunity to edit this document at a later time? For example to perform quality control sampling?

R6) There are no known latency issues in the Data Gateway that would restrict the speed in which operators enter data.

There is no opportunity to edit documents once entered in the Data Gateway.

Q7) Section 14&15 – Page 38 - Does the transport company require any elevated security certification?

What are the expectations re: 'value' of the shipments to determine insurance/liability coverage?

R7) Transportation company must be bonded. Bins will be locked.

- **Q8**) Section 4.1.1.1, M-2 Page 18 In the first paragraph of the question we believe the reference should be to Annex B, rather than Annex A. Please confirm.
- **R8)** Please see Solicitation Amendment # 002 that was posted on Buy and Sell to revise at Article 4.1.1.1 - M2 to replace the wording Annex A to Annex B.
- **Q9**) Section 7.3.1 Page 26 Under Part 7.3.1.3 Security Requirements, the Contractor MUST NOT utilize its Information Technology systems to electronically process, produce or store PROTECTED information until the CSP, PWGSC has issued written approval: If CSP is delayed in completing their initial inspection – how does this affect supplier contractually? Will CSP approve without a physical inspection but based on written documented specifications provided by bidder? As CSP is the approved Gov't organization to complete this inspection and has a limited number of inspectors would this inspection be given priority so that bidder can meet the designated start date?
- **R9**) Protected information utilizing Information Technology systems cannot commence until CSD has performed a physical site inspection to the successful bidders site. CISD will do their best to meet the designated start date. After approval has been granted or approved, these tasks may be performed at the level of PROTECTED B.



Q10) I do not see a listing of where the contract is to be completed., how do I learn in which city (or cities) this work will take place?

R10) No work site has been specified. ESDC requires that the winning supplier possess a Canadian location that meets security requirements, where all work will be performed. That the supplier possesses and maintains valid security certifications, and can ship and receive the required packages while maintaining the expected turnaround times.

Q11) Forms: Will we have to process various version of the same forms?

R11) Each form type has one version.

Q12) Forms: What is the % of the forms that will be filled out by hand versus printed?

R12) ESDC does not capture the percentage of forms that are handwritten or typed and is unable to provide an official approximate percentage.

R13) No web forms will require processing.

R14) No information in addition to that specified in the RFP is to be processed.

Q15) Forms: For the INS5097:

- If Region is missing, do we still process it (p.55)
- Will there be any instances where we would need to capture information on the attachments?

R15) - 1 file per region.

- No need to process if a region is missing.
- ESDC does not foresee any instance where this would be required.
