Questions and Answers

Q3. For Table A1: Lumbar Support - You have requested a fixed lumbar support. We have a chair that exceeds this requirement with lumbar adjustment built in at no additional cost. The user can choose not to the feature but it will be available. Can you confirm that this additional feature will also be acceptable if we provide a competitive price?

A3. This feature would be acceptable.

Q4. For Table A1: Seat Depth - You have requested Medium Fixed Seat Depth between 16.5" and 18.1". We have a chair that matches the measurements using an adjustable seat depth within that range, at no additional cost, which exceeds the requirement. The user can choose not to use the feature but it will be available. Can you confirm that these additional features will also be acceptable if we can provide a competitive price?

A4. This feature would be acceptable.

Q5. For Table A1: Tilt Mech - You have requested a Unison tilt at 1:1 tilt ratio. We have a chair that exceeds this requirement at a greater than 1:1 tilt ratio at no additional cost. The adjustment is also done with one lever in the same way a Unison tilt would be adjusted. Can you confirm that these additional features will also be acceptable if we can provide a competitive price?

A5. This feature would be acceptable.

Q6. For Table A1: Seat/Backrest Locks - You have requested Seat & Backrest Locks in Setup Position. We have a chair that exceeds this requirement as it locks in multiple positions including setup position. The user can choose not to use the feature, but it will be available. Can you confirm that these additional features will also be acceptable if we can provide a competitive price?

A6. This feature would not be acceptable.

Q7. For Table A2: Lumbar Adjustment - The "In/Out" Lumbar adjustment is not specified in ergonomic guidelines, such as BIFMA G1 or CGSB 44.232, therefore can you please revise this requirement to make the "In/Out" feature optional but not mandatory for the chairs in this requirement?

Table A2 requests a Fixed Lumbar Support. However, a chair with an adjustable lumbar that is capable of having the lumbar support locked into a position that meets the Fixed Lumbar Support dimensional criteria would also be acceptable.

Q8. For Table A2: Armrest Adjustment - You have requested Height and Width Adjustable - We have a chair that has Height and Pivot adjustment. The pivot adjustment will by definition include a width adjustment at the arm cap ends. Can you confirm that this option will also be acceptable?

A8. This feature would be acceptable.
