Q150 Amendment 021, A141: It is noted that Canada has published a revised Financial Bid Presentation Sheet in French. Will an English version be posted?

- A150 This is now posted.
- Q151 The professional services pricing table in the Basis of Payment for the resulting ADIS Acquisition contract (reference: table 1.1 of Annex B in Volume 2) lists only one firm all-inclusive hourly rate however the ADIS financial bid presentation sheet includes three proposed labour rates (for each of years 1, 2 and 3) per Category of Work. In the resulting contract for the ADIS Acquisition will the Basis of Payment Table be expanded to include the rates for each year, or will one column remain in which the rate will be an average of the rate for each of the three years?
- A1501 In the contract the basis of payment the table will be expanded to include the rates for each year.
- Q152 The professional services pricing table in the Basis of Payment for the resulting ADIS Acquisition contract (reference: table 1.1 of Annex B in Volume 2) includes a column with the heading Estimated Level of Effort. In the resulting contract does the bidder's estimate become a firm amount or is the resulting contract subject to upward or downward revision depending upon the actual amount of work performed?
- A152 The resulting contract subject to upward or downward revision depending upon the actual amount of work performed.
- Q153 Requirements 9 and 10 require the ADIS to "scan" the coverage area. Please define what is meant by "scan" and what output device is required?
- A153 As defined in the RAG (Appendix AE of Annex A References, Acronyms and Glossary): "The term scan / scanning is the process of examining the field of regard (e.g. continuously, by discrete sectors, etc.) with the purpose of detecting and identifying CWAs and TICs."
- Q154 Amendment 021, A139: Additional clarity is sought because the answer to the question begins with "No":
- Qi Is a manually positioned detector acceptable or is a motorized pan and tilt device required?
- Ai Motorized pan and tilt is required. The ability to detect CWAs/TICS and the assessment of the ability to move the detector head have been separated for the purpose of the bid evaluation. During operations, ADIS will be required to autonomously scan an area up to 360 degrees azimuth and -10 to +40 degrees elevation and detect/identify CWAs/TICs in that area.

Qii Assuming the answer "No" means the detector is not required to detect a chemical gas during movement defined in Requirement 12, it appears the time limit of 30 minutes is meaningless. The detector can simply be rotated to meet any time constraint?

- Qiii The DRDC bid evaluation testing methodology and test set-up is clear, however the response to the question talks about "real life". Please explain the real life scenario(s) that the ADIS will be used and whether these real life scenarios will become a contractual obligation for the Contractor?
- Aiii After contract award and during the qualification phases, the winning bidder will be contractually obligated to demonstrate that the system meets the specifications in the SysRS (Appendix AA to Annex A). This will include a demonstration at an outdoor test site with the release of CWAs and/or TICs at conditions described in the SysRS (Appendix AA to Annex A).
- Qiv Requirement 12 uses the term "complete monitoring coverage". Assuming the answer "No" means the detector is not required to detect a chemical gas during movement defined in Requirement 12, please explain what is to be "monitored"?
- Qiv Please see response to i.
- Q155 Can we apply from IRAN?
