QUESTIONS AND ANSWERS

Question 16: Given the complexity of the solicitation requirements and the number of revisions that have been issued to date, would Canada consider providing a two-week extension to the closing date?

Answer 16: Canada will extend the solicitation closing date to July 27, 2020. See Solicitation Revision 27.

Question 17: For MTC1-B, would Canada please clarify whether EACH contract identified in MTC1-A must have 2000 cumulative days, or can the contracts be combined? In other words, using Workstream 1 as an example: if Contract #1 had 1000 cumulative days (which included an Application/Software Architect but not a Programmer/Analyst), and Contract #2 had 1000 cumulative days (which included a Programmer/Analyst but not an Application/Software Architect), would this meet the criteria?

Answer 17: For MTC1-B, if the Bidder references two contracts in its response to MTC1-A, the Bidder must demonstrate that both contracts have a combined cumulative total of at least 2,000 billable days for the resource categories including those specified in the criterion.

For clarity, the three year period in which the billable days were completed in one reference contract may or may not be the same as the three year period in which the billable days were completed in the second reference contract. Therefore, the Bidder must specify the start and end date of the three-year period in which the billable days were completed for each contract. Please see Solicitation Revision 28.

ALL OTHER TERMS AND CONDITIONS REMAIN THE SAME.

NOTE: A BID ALREADY SUBMITTED MAY BE AMENDED PRIOR TO THE CLOSING DATE. AMENDING CORRESPONDENCE MUST ADDRESS THE SOLICITATION NUMBER AND THE CLOSING DATE.
