### 1. QUESTIONS AND ANSWERS

**Q1.** Appendix 3 Finance Proposal; Table E

- Quantity: 1 to 499; and
- Quantity 500 to 999.

The specification of this booklet is such that it's not practical and economical for CRA, or the supplier to manufacture a quantity that could be potentially 1 unit/booklet, as per the Quantity Range: 1-499. Is it acceptable to CRA for the Remittance Booklet to be quoted under the condition of a minimum of 1,000 booklets for any order?

- A1.** No, that would not be acceptable. It is highly unlikely that we would need only one booklet, but it is quite likely that we will require quantities of less than 1,000.  
However, CRA would accept changing the quantity range from 1-499 to 100-499, with a minimum order quantity of 100.
